

With reference to the above mentioned letter dated 30.06.2021 from Deputy Inspector General of Forests (Central), Regional Officer, Jaipur vide which stage -I /In-Principal approval for the said proposal has been conveyed subject to certain terms and conditions (copy enclosed). You are hereby requested to deposit the cost of compensatory afforestation and NPV as per the details given below:-

1. The cost for compensatory afforestation at the prevailing wage rate it is informed that you shall deposit an amount of Rs. 2,16,60,380/- (Rupees Two Crore Sixteen Lakh Sixty Thousand Three Hundred and Eighty only) which include the cost of creation of 2660 saplings, their maintenance for ten years and anticipated cost increase @7.5%)
2. With respect to point no. 1, it is informed that the Net Present Value (NPV) for 2.66 ha of forest area to be diverted amounts to RS. 2359420/- (Rupees Twenty Three Lakh Fifty Nine Thousand Four Hundred and Twenty only).
3. Therefore, you are requested to deposit both cost for compensatory afforestation and Net Present Value (NPV) to CAMPA fund through e-portal by generating online challan (<https://parivesh.nic.in>).

You are hereby directed to submit the compliance of aforesaid conditions at the earliest to this office which has to be forwarded to MoEF&CC, Regional Office, Central Region, Lucknow for obtaining Stage-II approval.
