**Sub:-** Dr B.R.Ambedkar Pranahitha Project-Adilabad district- Detailed investigation, preparation of designs, drawings, estimates, land plan schedules and excavation of Gravity canal including formation of embankments, construction of sluices, CM & CD works, , distributory system and excavation of field channels and its structures to creat an Irrigation Potential of 56,500 acres ayacut, for a length of 71.50 Km of main canal, which is taking off from the right flank of the proposed barrage across Pranahitha near Tummidihetti(V), Koutala(M), Adilabad district- Diversion of CA land, Forest proposals-Furnished – Reg.

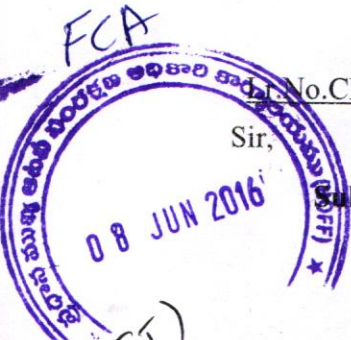

I am to submit that as discussed in the meeting convened by the Spl Chief Secretary in reference cited, the proposals uploaded online earlier for diversion of forest land to an extent of 3170.4445 ha has been withdrawn as per the request of the Chief Engineer ,Dr B.R.A.P.C.S.S in reference 2<sup>nd</sup> cited.

Now, as per re-organisation, the Link-I of Dr.B.R.A.P.C.S.S in Adilabad district comprises of construction of Barrage at Tumidihetti Village and main canal for a length of 71.50 Kms to irrigate an ayacut of 56,500 acres. This component is now being called as Dr.B.R. Abmedkar Pranahitha Project and is now being looked after by the undersigned.

An extent of 1081.0478 ha (567.0478 ha under DFO Adilabad, 479.58 ha under DFO Bellampally & 34.416 ha under DFO Mancherial) is involved in the above project which was already authenticated by the Principal Chief Conservator of Forest.

It is proposed to divert the required extent of 1081.0478 ha towards compensatory afforestation from the available CA land of 2028.089 ha which has been verified by the respective DFOs and communicated by the Principal Chief Conservator of Forest vide Lr No 32443/ 2011/FCA-1/TS dated 20.12.2014.


