Now, therefore, the parties to this Indenture of Partnership mutually agree and conform to the terms and conditions as follows:

1. NAME AND STYLE:
 That the name and style the partnership firm shall be "M/S. Trevi Hospital" with its principal place of business situated at 91 Meitei Langol, Imphal West, Imphal (Manipur). The partners may also open such other branch/branches at such places/branches and in such other name/names as may be mutually agreed upon from time to time.

2. DATE OF COMMENCEMENT AND DURATION:
 That the business of the partnership firm shall commence promptly from 01/04/2019 and it shall continue for an indefinite or indeterminate period till it is dissolved by parties hereof in future.

3. NATURE OF BUSINESS:
 That the business of partnership firm shall be to build and run a hospital for providing the facilities of medical care and treatment in different fields and encourage research and development of new methods of diagnosis and treatment of diseases.

4. CAPITAL:
 That the capital of the partnership business shall be the amount contributed by the partners hereof from time to time in any proportion irrespective of the extent of their respective shares in the partnership business.

5. INTEREST ON CAPITAL:

9. BANK ACCOUNTS:

14 BOOKS OF ACCOUNTS:

That the proper books of account and/or records pertaining to business of the firm shall be maintained. Both the partners shall have free access to them during business hours and shall be at liberty to inspect, copy or take extracts therefrom.
