Please refer to your application Serial Number KNL/ PAS /09 On subject and the
subsequent interview / draw held for selection at COMMUNITY CENTRE, PRC on
30.08.2016.

It is intended to offer you LPG Distributorship at PASINA KALAN on conditions
that you will:

1. LPG STORAGE GODOWN & SHOWROOM

You should provide a godown for storage of 8000 kg (minimum) of LPG filled in
cylinders. The LPG Storage godown should be approved and licensed by Chief
Controller of Explosives of Petroleum and Explosives Safety Organization (PESO)
and should have mastic flooring.

You should also have a showroom of dimensions 3m X 4.5 m in the advertised
location or locality specified in the advertisement.

The construction of godown and showroom should be completed within a period of
four months from the date of this letter. Both godown and showroom should be
freely accessible through all weather motorable approach road.

Construction of godown / showroom should be commenced only after permission in
writing is obtained from this office.

2. FINANCE

Make all financial and other arrangements for operating the Distributorship
within four months from the date of this letter.

3. DELIVERY INFRASTRUCTURE

Make arrangements for delivery vehicles for effecting home delivery of LPG
cylinders.

4. PERSONAL SUPERVISION

You should personally manage the LPG distributorship operations.

If already employed, you will have to submit acceptance of resignation letter from your employer prior to the issuance of Appointment Letter by us. In addition to the above, you will also submit a Notarized Affidavit certifying that you are not employed in private sector or are not drawing any salary/perks/emoluments (other than pension) from the State/Central Government before the issuance of Letter of Appointment by us as per the attached format.

5. COMMISSIONING

5.1. Make all out efforts to commission the LPG Distributorship within four months from the date of this letter.

5.2. If we find that the progress being made by you towards the above is not to our satisfaction, this offer is liable to be withdrawn.

5.3. Operate the LPG Distributorship personally.

5.4. You will induct your spouse as co-owner i.e. 50% partner. You are not permitted to induct any one as your partner other than your spouse nor make any changes in the constitution of the proposed distributorship in a manner other than what was intended at the time of application, without prior approval from Corporation.

5.5. Shift your residence to PASINA KALAN (if you are presently staying away from the location) in order to personally operate the LPG Distributorship as stated in para 4 above and give us a written undertaking to this effect.

5.6. If already employed, you will have to submit acceptance of resignation letter from your employer prior to the issuance of Appointment Letter by us.

5.7. You will have to undergo training on LPG Distributorship operation for one to two weeks after which you will have to take a quiz. Your score should not be less than 80% marks. Failing which you will have to again undergo re-training so that you can score minimum 80% marks.

5.8. Provisionally it is intended that your area of operation will cover WITHIN THE 15 KM RADIOUS and its 15 kms radius. This is however, subject to changes as may be considered necessary by the Corporation at a later date, even after the distributorship is commissioned. Further besides release of new connections, from time to time, you may be required to take over some existing customers from other distributors in your area of operation. Similarly, you may be required to surrender some customers to other distributors.

6. After you have complied with the conditions spelt out herein above, you will be confirmed / formalized by an Appointment Letter followed by the signing of our standard LPG Distributorship Agreement by both you and us.

7. The tenure of the distributorship shall remain in force for an initial period of 5 years from the date of execution of Distributorship Agreement and continue thereafter until determined as per rights mentioned in the Distributorship agreement

8. You will be required to deposit interest free refundable security deposit of 2.50 lakhs. The amount of Rs. 25000/- or Rs. 50000/- (strike out which is not applicable) remitted by you before FVC can be adjusted against this deposit.

The Corporation will have the right to adjust any dues to us from this amount at the time of resignation/ termination.

However, in case of termination of the LPG Distributorship on account of proven malpractice, the said security deposit shall be forfeited.

9. WITHDRAWAL OF LETTER OF INTENT

9.1. This letter is merely a Letter of Intent and is not to be construed as a 'firm offer' of LPG Distributorship to you. If we find that the progress being made by you towards the above is not to our satisfaction, this letter is liable to be withdrawn along with forfeiture of the amount deposited by you with the Corporation before FVC .

9.2. Our offer will stand automatically cancelled in case you have received Letter of Intent for any other Dealership / Distributorship/RGGLV either of our Company or any other Oil Company, in your individual capacity or by any member of your 'family unit'

9.3. If any statement made in the application or in the documents enclosed therewith or subsequently submitted in pursuance of the application by you at any stage is found to have been suppressed / misrepresented / incorrect or false affecting eligibility, then the LOI is liable to be withdrawn without assigning any reason along with forfeiture of the amount deposited by you with the Corporation before FVC and in case you have been appointed as a distributor, the distributorship is liable to be terminated along with forfeiture of the security deposit remitted by you. In such cases you shall have no claim whatsoever against the respective Oil Company.

10. This letter does not permit or authorize you to start enrolment of customers and/or obtain money by way of advance or towards purchase of stove/gas burners until a regular LPG Distributorship Agreement is executed and you are appointed as LPG Distributor.

11. Public Sector Nationalized Banks and Indian Scheduled Commercial Banks in the Private Sector may consider advancing loans at reasonable terms to you. A copy of this letter is being marked to the lead bank PNB for their information so that as and when you approach them they can consider for financial assistance in line with their policy.
