- i) Short narrative of the proposal and project/scheme for which the forest land is required :: The Government has accorded administrative sanction for the Road work "**Providing BT surface to the Road from R.S Rangapuram to Yaganti (via) Ambapuram, Katikavanikunta of Bethamcherla Mandal**" vide District Collector Admn. Sanction Proc. No.139/SDP/Dy.SO(3)/2015, Dt.30.03.2017 under Special Development Package with an estimate cost of Rs.5.00 Crores. It is very important road connecting temples at Maddilety Swamy near Rangapuram and Yaganteswara swamy at Yaganti, which are very ancient temples in Kurnool District and pilgrims visit the temples throughout the year. These temples can be connected, if the road is laid for a length of 11.30 Kms, out of 11.30 Kms length, there is cart track in KM 0/0 to 7/8 i.e., 7.80 Km and the balance length in KM 7/8 to 11/3 i.e., 3.50 Km is BT Road. At present the distance between two temples as per the existing R&B road connection is about 50 Km. By providing the above sanctioned Road the distance between the temples will be reduced by 38.70 Km which reduces time and fuel consumption

also. In addition 2 unconnected habitations i.e., Katikavanikunta and Fathenagar will also be connected by all weather Road. During the execution, from KM 2/790 to KM 3/650 i.e., 860 mts is falling in Compt.No.332 of Rangapuram Reserve forest of Dhone Range of Kurnool Division with a total extent of 0.99 Ha. area required for diversion. Therefore a proposal for diversion for 0.99 Ha. forest land is proposed for executing this project.
