Subject: Diversion of 24.001 ha of forest land for improvement & up-gradation of existing road to 4-lane with paved shoulder of Imphal-Kohima Road Section from Kuraopokpi to Nilakuthi in the State of Manipur on EPC mode by NHIDCL.

Sir,

With reference to the subject cited above I am to say that the Ministry of Environment, Forests & Climate Change, North Eastern Integrated Regional Office, Shillong has accorded "In Principle Approval" for diversion of 24.001 ha of forest land for improvement & up-gradation of existing road to 4-lane with paved shoulder of Imphal-Kohima Road Section from Kuraopokpi to Nilakuthi in the State of Manipur on EPC mode by NHIDCL vide their letter F. No.3-MN C 010/2021-SHI/455-456 dated 31st May, 2021 (copy enclosed). In this regard I am to inform you to deposit the mandatory levies to **CAMPA** through the e-Portal (<http://parivesh.nic.in/>) following due procedure

Further cost estimates for (i) demarcation of the land proposed for diversion, (ii) erection of cement-concrete boundary pillars and (iii) felling, logging and transportation of project affected trees land (iv) estimates for planting dwarf medicinal plants along the right of way will be submitted in due course for depositing to the account of the concerned Divisional Forest Officer in compliance with conditions laid down in the approval so that necessary working permission can be issued at the earliest.
