The Public Works Department National Highway, Zone, Jabalpur, Madhya Pradesh state is working on Jabalpur-Kundam-Shahpura-Dindori Road Declared as NH-45 Ext. The road stated above passes from forest area in Dindori District and for the Rehabilitation and Upgradation of the roads as per as the National Highway standard, there is a requirement of forest land. The minimum required forest land is 8.456 Ha in Dindori District. There is no issue of Forest Right Act, 2006 on the forest area passing through the project road. As per as the letter no, F.No. 11-9/98-FC (pt), dated-5th February, 2013 of ministry of environment and forests (FC Division), there is no requirement for No Objection Certificate (NOC) from Gram Panchayat of those villages where forest area is coming on the road.,

Therefore, it is requested to issue Forest Right Act (FRA) certificate for forest land coming between Jabalpur-Kundam-Shahpura-Dindori Road Declared as NH-45 Ext.
