

BASUNDHARA (W) EXTENTION OCP

REHABILITATION AND RESETTLEMENT PLAN

The lands belonging to village Gopalpur, Ratansara and Jamkani Reserve forest of Hemgir Tahasil, District-Sundargarh, Odisha are involved in Basundhara (W) Extention Project. The Basundhara (W) Extention Project includes the Mining Area, Safety zone and Infrastructural Area.

Total 323.92 Ha (800.41 acres) of land is involved in Basundhara (W) Project. Out of which 51.29 Ha is tenancy land, 45.01Ha is Govt. (NF) land, 184.62 Ha is Revenue forest land and 6.06 Ha is RF land (Reserve Forest).

Out of **51.29 Ha** of tenancy land involved in this project, 40.18 Ha (99.28 acres) belongs to village Gopalpur and 11.11Ha (27.45 acres) belongs village Ratansara. The lands of village Gopalpur and Ratansara have been acquired under CBA (A&D) Act, 1957 vide Notification u/s 9(1) of the said Act vide SO No. 1869 dated 10.07.1989 and vested with MCL u/s 11(1) of the said Act vide SO No. 2592 dated 13.09.1990.

The payment of Compensation and R&R benefits for the village Gopalpur and Ratansara including other 12 villages have been under taken by the Claims Commission, set up by the Hon'ble Supreme Court of India in SLP© 6933 of 2007. The compensation for land and structures for village Gopalpur has been disbursed to the beneficiaries and for village Ratansara Survey has been completed by the Claims Commission.

Rehabilitation and Resettlement benefits are being provided to the affected families of village Gopalpur under Orissa R&R Policy 2006 as per recommendation of the Hon'ble Claims Commission and approval of the Hon'ble Supreme Court. For extending R&R benefits to the villagers of Ratansara the project affected persons list (PAF list) will be prepared by MCL and then it will be submitted to the Claims Commission. The Commission will publish the list in the village for objections if any and then list will be finalized by the commission and will be submitted to the Supreme Court for approval. After approval of the list the R&R benefits will be given to the villagers.

Approximately, 316 families from these villages will be displaced/ affected due to this project as per the approved PAF list of village Gopalpur and and Record of Rights of village Ratansara.

Note: The above figure of the families expected to be displaced / affected is based on PAF list of village Gopalpur and the ROR of village Ratansara. However, the figure may vary after detail family survey report of village Ratansara. The Rehabilitation and Re-settlement to the affected families of village Gopalpur are being extended as per the Odisha R&R Policy 2006, recommended by the Claims Commission and approved by the Hon'ble Supreme Court. The Rehabilitation and Resettlement to the affected families of Ratansara will also be given as per the Orissa R&R policy 2006 after approval of the PAF list by Hon'ble Supreme Court.

Payment of Compensation for land and structures: The compensation for land and structures has already been paid to the affected/displaced families of **Gopalpur**. An amount of Rs 284.50 crores has been disbursed out of sanctioned amount of Rs 360.96 crores. For village **Ratansara** the survey has been completed and the compensation roll is yet prepared and finalized.

Employment & Resettlement benefits to village Gopalpur & Ratansara.

As per the approved PAF list of village **Gopalpur** there are 618 families in Cat-I for employment. Out of them, 393 families are employed/ paid cash in lieu of employment/annuity. In other cases the notices have been served to the beneficiaries to join in service/receive payment of cash in lieu of employment .

Further, there are 106 families are in Cat-III. They are offered cash against employment @ 7.00 lakhs/family. There are also 71 families in Category-V. These families will also be given cash in lieu of employment @Rs 3.50 lakhs/family.

Further the Hon'ble Supreme Court has sanctioned Monetary Compensation to 283 families under category-I who are over aged for employment. They are also offered cash @ Rs 10.00 lakh/family.

For village **Ratansara**, the employments as well as cash in lieu of employment/MC will be given after direction of the Hon'ble Supreme Court.

Resettlement of Displaced families of village Gopalpur and Ratansara:

In village Gopalpur, 981 families will be resettled. Out of them, 128 families have opted for cash in lieu of re-settlement benefits. They have been paid @ Rs 5, 78,000/family.

The MCL's scheme for resettlement has been given below:

The other displaced families who will not choose for self re-location will be resettled at Sarangijharia and Badkhalia. In Sarangijharia village, 88.00 acres of Govt. non forest land has been taken on lease by MCL and in village Badkhalia 55.44 acres have been purchased from private owners for

establishment of re-settlement site. The development works in both the sites will be started soon.

The re-settlement site village **Ratansara** will be decided after approval of PAF list by the Hon'ble Supreme Court.

CORPORATE SOCIAL RESPONSIBILITY OF MCL

MCL has undertaken corporate social responsibility in various spheres. Different peripheral development and community development works have been carried out.

A. Sanitation:

- i. Construction of toilets in Schools.

- i. Renovation / installation of hand pumps.
- ii. Renovation / construction of Wells.
- iii. Renovation / digging of ponds.

C. Education:

- i. Construction / repair of educational building
- ii. Provision of additional facility, furniture, lab instruments etc.

D. Rural Health Care:

- i. Organizing camps for eye operation/ post operation care / welfare camps.
- ii. Provision of medical instruments to the village hospitals.
- iii. Provision of medical facility to the rural population through mobile medical vans.

E. Roads:

- i. Construction and repair of rural roads.
- ii. Construction and repair of roads connecting mining area.

- iii. Construction and repair of culverts.
- iv. Construction and repair of bridge.

F. Recreation Centers:

- i. Construction of Community Centers.
- ii. Providing financial aid to the various social institutions.
- iii. Preparation of playgrounds and organizing sports.

G. Environment :

- i. Plantation of various species in the nearby villages of mining area.
- ii. Distribution of saplings – fruit bearing plants, medical plants and avenue plants.

H. Other Miscellaneous heads:

- i. Street lighting
- ii. Providing facilities to various institutions.
- iii. Providing facilities to district level administration offices.
