It is informed that, wherein the Prl.Chief Conservator of Forests, (HoFF), Andhra Pradesh, Guntur has communicated stage-I approval under section- 2 of Forest Conservation Act, 1980 for diversion of 0.51 Ha of forest land in Compartment No 127 of Kondaveedu (Extn.I) RF in, Guntur Range of Territorial Division Guntur for Erection of 2 Phase 132 KV DC/SC line from 132 KV Substation Nallapadu to the proposed Railway Traction Sub-Station, Nallapadu in favour of Executive Engineer, Construction Division, A.P, TRANSCO, Guntur, subject to the conditions stipulated therein.

In this regard the Executive Engineer, Construction Division, A.P, TRANSCO, Guntur is requested that he should pay the amount in the following accounts,

2	The user agency shall deposit an amount of Rs.56.00 Lakhs as compensation for infrastructure existing in the premises of Nallapadu Central Nursery and Nagaravanam as calculated by the Divisional Forest Officer, Guntur.	56.00 Lakhs	The User agency should pay through e-payment mode i.e. challan generated through the Ministry's website portal (i.e. www.forestclearance.nic.in) in Adhoc- CAMPA, as per the guidelines issued by the Ad-hoc CAMPA, New Delhi letter dated.09.06.2016

The User Agency is also informed that 1) the existing bore well which catering the needs of Central nursery and for children park in Nagaravanam is to be retained in the same place. The User Agency should not obstruct bore well and existing pipe line in any manner. The User Agency not have any right on the existing bore well and pipe line. 2) The existing electrical transformer which was erected with the cost of Forest Department to cater the need of water for nursery Bore wells and Quarters in the proposed area. The User Agency has to shift the transformer which their cost if necessary and also submit the under taking certificates to the above two conditions.

Further it is informed that the user agency should comply with the following in accordance with the Govt. of India instructions issued cited F.No.7-23/2012-FC, dt.24.07.2013 and publish the orders at the cost of the project proponent.

1. Publish the entire forest clearances granted in verbatim along with the conditions and safe- guards imposed by the Central Govt. in two widely circulated daily news papers, one in vernacular language and the other in English language, so as to make people aware of the permission granted to the project proponent for use of forest land for non- forest purposes.
2. The copies of the Forest Clearance should be submitted to the Heads of local bodies, Panchayats and Municipal Bodies by the project proponents in addition to the relevant offices of the Government who in turn has to display the same in 30 days.

And also it is requested to the Executive Engineer, Construction Division, A.P, TRANSCO, Guntur to furnish the compliance as per the conditions stipulated in the reference 3rd and 4th cited above with condition wise relevant proofs / under takings in shape of 4 sets for onward submission to the Prl. Chief Conservator of Forests, (HoFF), A.P., through Chief Conservator of Forests, Guntur for further necessary action and for obtaining the final approval.
