Accordingly, technical sanction was accorded and tenders were called on eprocurement platform and the agency finalized. The SE/HYD Circle has concluded Agreement vide Ag No 45/20-13 dt 28.02.13. The works are under good progress i.e the construction of head wall, Intake pipe line, jack well cum pump house, staff quarters, errection of pumps is completed. The laying of 1700 mm dia pressure main is completed 8160 Mts out of 8910 Mts and 1100 mm dia pressure main is completed 11880 Mts out of 12630 Mts.

The balance length of 750 Mts pipe line & power line is passing through the Chintalapalem reserve forest which occupies an extent of 0.82 Hectares.

For diversion of forest land, DGPS Survey was conducted and the survey report is herewith enclosed.

In view of the above, the Principal Chief Conservator Of Forests (HOFF), Telangana State is requested to accord clearance to an extent of 0.82 Hectares to complete the works in stipulated period and create irrigation potential of 13390 acres.
