Kind attention is invited to the reference 1st cited where in it has been asked to submit proposal for regularization of diversion of RF land. Accordingly this proposal is submitted.


The Singareni Collieries Company Limited (SCCL) is a Government Company jointly owned by the State Government and the Central Government (51:49). This is the only Coal Mining Company in South India which is supplying coal to meet the energy needs of various industries in South India. SCCL is having (44) Coal Mining Leases as on date and the Mining Operations are spread over in Seven (7) Districts viz., Khammam, Badhradri Kothagudam, Jayashankar Bhupalpalli, Mulugu, Peddapalli, Mancherial and Komuram Bheem Asifabad. Presently SCCL has been operating **27** Underground Mines and **19** Open Cast Mines. The coal target fixed by the Govt. of India as **70** million tonnes for the year 2020-21.
