I invite your kind attention to the reference cited above. I kindly request to take necessary action to modify and resubmit the proposal for obtaining permission for the work of Collection system for providing UGSS to Theni – Allinagaram Municipality in Theni District is under progress. In this project the sewer sub main of 200mm dia stoneware pipes has to be laid for a length of 90mtr in forest land along the edge of Forest boundary which falls on western side of forest stretch in the location namely "Valkaradu" area for linking branch sewers to be laid in Municipal areas located adjacent to the forest Boundary.

Hence, I enclose herewith a detailed proposal for laying 200mm sewer line to a length of 90 m and construction of 4 Nos of manholes in the forest boundary in the prescribed format for want of necessary permission.

In this I like to inform that this stretch of forest land is seemed to be an unformed track being utilized by near by people for their vehicular traffic and other public utilities are already exists there. While starting our works as these areas we came to known that this stretch of land falls in forest land which is the extreme end of forest boundary. Moreover we have no other alternate route except this alignment for completing this sewer network. The sewerline is to be laid over the existing pathway of nearby area

people. The Theni – Allinagaram Municipality will not claim any ownership in the future. The laying of sewerline doesnot disturb any trees are herbs in that area.

Since, this UGSS project to Theni – Allinagaram Municipality is completed and brought in to use by the Honourable Chief Minister on 08-06-2015, I kindly request that necessary permission may please be granted for laying 200mm sewer line to a length of 90mtr and construction of 4 Nos of manholes in this small stretch of forest land. Further the work is now executed by Tamil Nadu Water supply and drainage Board. After the Completion of work, the scheme will be taken over by Theni-Allinagaram Municipality for further maintenance.

Hence, I request your kind Co operation in perusal of this proposal and according early permission so as to take up this work early.
