- All the funds i.e. cost of CA, & NPV to the tune of Rs. 24,036/- & Rs. 27,960/- (Total IV. amounting to Rs. 51,996/-) respectively be deposited through e-payment portal by internet banking, e-challan through RTGS or off line challan mode RTGS/NEFT in Union Bank of India, Sundernagar, New Delhi- 110003 bearing RTGS/IFSC No. UBIN0534498, in the account favouring HIMACHAL PRADESH CAMPA Account No. 344902010105419 at the earliest and UTR slip duly attested be submitted to this office and a Demand Draft of an amount of Rs. 4006/- as departmental charges be submitted in this office favouring Divisional Forest Officer, Rampur Bushahr.
- An undertaking to the effect that after completion of construction work user agency will. undertake plantation work on the remaining empty space at the cost of user agency.
