For Erection of 400KV QMDC Line from the proposed 1x800 MW Power Plant in KTS (Paloncha) to the proposed 400/220KV SS at Padamati Narsapuram (V) Julurupadu (M) in Khammam (Dist). In which (1) 19.186 Ha of forest land of Chatakonda RF block in of Kothagudem Forest Division and (2) 10.5018 Ha of forest land in Chatakonda & Punukula RF in Paloncha Wild Life Forest Division including Eco sensitive zone proposals - Request for according approval – Reg.

With reference to the subject work towards diversion of forest land for an extent of 18.5334 Ha. Proposals were submitted to the Principal Chief Conservator of Forest, Hyderabad for according approval vide reference 2<sup>nd</sup> cited above.

But it is learnt that in vide reference 4<sup>th</sup> cited , the raw data of the DGPS survey report has been authenticated to an extent area of 19.186 Ha. Accordingly the revised proposals submitted to DFO/ Kothagudem vide ref 8<sup>th</sup> cited above.

But apart from above, further it is to inform that, at present in Kinnerasani Wild Life Sanctuary, forest was identified which is unavoidable under any circumstances.

By including these two proposals the total length of the line passing through the forest is 6453.91 mtrs and the 400KV DC line requires forest width 46 meters. Area comes to 6453.91 X 46 mtrs = 29.6878 Ha.

1. 4170.91 mtrs of Kothagudem Forest Division (19.186 Ha)
2. 2283 mtrs of Paloncha Wild Life Forest Division. (10.856 Ha)

Hence the diversion of forest land has been proposed for an area of 29.68784 Ha. including Eco sensitive zone proposals


