With reference to the subject work towards diversion of forest land for an extent of 24.1454 Ha. Proposals were submitted to the Principal Chief Conservator of Forest, Hyderabad for according approval vide reference 2nd cited above.

But it is to inform that, at present in Kinnerasani Wild Life Sanctuary, forest was identified which is unavoidable under any circumstances.

The total length of the line passing through the forest is 8199 mtrs and the 400KV DC line requires forest width 46 meters. Area comes to 8199 mtrs X 46 mtrs = 37.7154 Ha.

- 1. 4176 mtrs of Kothagudem Forest Division (19.2096 Ha)
- 2. 1073 mtrs of Chinthiryala & Rathangutta RF of Paloncha Forest Division (4.9358 Ha).
- 3. 2950 mtrs of Paloncha Wild Life Forest Division (13.57 Ha). Hence the diversion of forest land has been proposed for an area of 37.7154 Ha. including Eco sensitive zone proposals.
