In Continuation of this office reference 5<sup>th</sup> cited, it is to inform the Superintending Engineer, PIPRMC Circle, Eluru that based on the report of the Divisional Forest Officer, Visakhapatnam report in the reference 1<sup>st</sup> cited, a demand notice for payment of Compensatory Afforestation amount of **Rs.9,24,59,000/- (Rupees Nine crore twenty lakh Fifty Nine thousand)** was issued to the SE, PIPRMC, Eluru vide this office reference 2<sup>nd</sup> cited. Accordingly, the User agency paid the said amount and reported vide reference 3<sup>rd</sup> cited.

But, in the reference 4<sup>th</sup> cited, the Divisional Forest Officer, Visakhapatnam **(copy enclosed for ready reference)** has furnished a revised Compensatory Afforestation Scheme for **Rs.2696.89 lakh (Rupees twenty six crore ninety six lakh eighty nine thousand only)** as per the guidelines communicated by Government of India.

Based on the above revised CA demand notice received from the Divisional Forest Officer, Visakhapatnam, the Superintending Engineer, P.I.P.P.R.M.C Circle, Eluru, is hereby requested to deposit the differential amount of **Rs.17,72,30,000/- (Rupees Seventeen crore seventy two lakh thirty thousand) only towards the CA** whose details are as follows:
