In the reference 1<sup>st</sup> cited, the proposal duly processed under FC Act for diversion of 0.9723 Ha of Forest Land for widening and up-gradation of Nakrekal – Nagarjunasagar section of NH 565 from Km **72/460 to 73/395** (0.935 Km) in Nellikal RF, part of Amrabad Tiger Reserve of Wildlife Division Nagarjunasagar to two lane with paved shoulder in f/o Executive Engineer, R&B NH Division, Hyderabad was submitted to State Govt.

Further, in the reference 2<sup>nd</sup> cited, the Govt. has communicated the minutes of 1<sup>st</sup> State Board for Wild Life meeting. In the said meeting 17 proposals for diversion of forest land passing through WL sanctuaries have been recommended and forwarded to National Board for Wild Life for its approval. The subject proposal is one among them, which was recommended by the SBWL.

With respect to online submission of proposal on Ministry's portal, it is submitted that as per the information available on Ministry's portal the present file is "pending at CF due to EDS raised by Nodal Officer" on 17.02.2016.

In compliance to the instructions received in the reference  $3^{\rm rd}$  cited, the APCCF (FCA), O/o the PCCF, TS, Hyderabad is requested to kindly withdraw the proposal on the subject project online in-order to enable us to subject the proposal afresh, as the then Chief Conservator of Forests has not recommended the project online & there is no option to revise the recommendations once the information \ details are fed into the

online portal.
