The expression, unless, repugnant to the context or meaning thereof, shall be deemed to include its successors.

Karbi Anglong Autonomous Council an Autonomous District council constituted under the provision of the Sixth Schedule of the Constitution of India having its headquarters at Diphu; hereinafter referred to as First party or KAAC. The expression, unless, repugnant to the context or meaning thereof shall be deemed to include its successors.

### AND

Assam Power Generation Corporation Limited, a company incorporated under the Company Act 1956, having its registered Office at Bijulee Bhawan, Paltan Bazaar, Guwahati-1 in the state of Assam; hereinafter referred to as Second party or APGCL Ltd. The expression, unless, repugnant to the context or meaning thereof, shall be deemed to include its successors.

Now, whereas, the Second party i.e. APGCL is going to acquire 90 Hectares of non-forest land in Karbi Anglong District for Compensatory Afforestation in order to compensate for the forest land to be diverted during the implementation of the proposed Lower Kopili H.E. Project and other small Hydro Electric Projects in the Borpani Basin of Karbi Anglong District. The land so acquired shall be transferred to the ownership of Forest Department, Govt. of Assam, for carrying out the necessary Compensatory Afforestation
