In compliance of the Ministry of Environment and Forests (MoEF) Government of India's letter No 11-9/98-FC (pt) dated 3rd August 2009 where in the MoEF issued guidelines on submission of evidences for having initiated and completed the process of settlement of rights under the Scheduled Tribes and Other Traditional Forest Dwellers (Recognition of Forest Rights) Act 2006 (FRA, for Short) on the Revinew land proposed to be diverted for non forest purposes read with MoEF's letter dated 5th February 2013 wherein MoEF issued certain relaxation in respect of linear projects, it is certified that **2.00 hectares** proposed to be diverted in favour of Sagar Zoo and Resque Center of Arjani, Aameth, Ghughar Village(s) in Sagar tehsils.

It is further certified that :-

- (a) The complete process for identification and settlement of rights under the FRA has been carried out for the entire **2.00 hectares** of forest area proposed for diversion. A copy of records of all consultations and meetings of the Forest Rights Committee(s); Gram Sabha(s), Sub Division Level Committee(s) and the District level Committee are enclosed as annexure-I to annexure 6.
- (b) The diversion of Revinew land for facilities managed by the Government as required under section 3(2) of the FRA have been completed and the Grama Sabhas have given their consent to it;
- (c) The proposal does not involve recognized rights of Primitive Tribal Groups and Pre-agricultural communities.

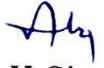

It is further certified that:

- (a) The complete process for identification and settlement of rights under FRA has been carried out for the entire 2.00 hectares of forest area proposed for diversion. A copy of records of all consultations and meetings of the Forest Rights Committee(S), Gram Sabha(S), Sub-Division Level Committee(S) and the District level Committee are enclosed as annexure-I to annexure-6
- (b) The proposal for such diversion (with full details of the project and its implications, in vernacular/local language) have been placed before each concerned Gram sabha of forest-dwellers, who are eligible under the FRA.
- (c) The each concerned Gram sabha (s) has certified that all formalities /processes under the FRA have been carried out and they have given their consent to proposed division and compensation and ameliorative measures, if any having understood the purposed and details of proposed division, A copy of certificate issued by the Gram Sabha of Arjani, Aameth, Ghughar villages (s) in enclosed as Annexure-I to annexure-6
- (d) The discussion and decision of such proposal had taken place only when there was a quorum of minimum 50% of member of Grama sabha present;
- (e) The diversion of Revinew land for facilities managed by the Government as required under section 3 (2) of the FRA have been completed and Gram Sabhas have given their consent to it;
- (f) The right of primitive Tribal Ground and Pre Agricultural Communities, where applicable have been specifically safeguarded as per section 3 (1) (e) of the FRA.
