Sub: Forest (Conservation) Act.1980 - Diversion of 0.26 Ha. of forest land for twenty years (20 years) for widening of Mulaiyur - Alanganallur road in Perumalai Reserved Forest of Dindigul Division, Dindigul Circle in favour of Divisional Engineer, Construction and Maintenance (High ways) Madurai on behalf of Highways Department - Order issued - Regarding.

I wish to inform that the Government has accorded permission for diversion of 0.26 Ha. of forest land for twenty years for widening Mulaiyur-Alanganallur road in Perumalai Reserved Forest in Dindigul Forest Division, Dindigul in favour of the Divisional Engineer Construction and Maintenance (H), Madurai-2 on behalf of Highways Department in the following conditions.

The user agency shall pay the Net Present Value of the diverted area of the rates stipulated by the Ministry of Environment and forest .

The Net present Value(NPV) is fixed as Rs.1,13,880/- by the Forest Department as per order of the Hon'ble Supreme Court of India dated:28.03.2008 and 09.05.2008 in I.A.No.826 in 566 with related interlocutory Applications in W.P.No.202/1995.

The amount Rs.1,13,880/- shall be deposited either SB A/C No.1025227-CAF, Tamil Nadu, Corporation Bank, CGO Complex, Lodhi Raod, New Delhi - 110 003 (RTGS/IFSC No. CORP 0000371) in SB Account No.344902010105433 - Tamil Nadu CAMPA, Union Bank of India, Sundar Nagar, New Delhi- 110 003 (RTGS/IFSC No. UBI No.534498). The details of deposition of funds including inter-alia the DD Nos. and date, amount the Bank on which drawn and the date of deposition in the designated Bank shall also be furnished. The User Agency shall generate chalan from the Ministry's Online web portal to deposit the amount towards compensatory levies.


The lease rent is fixed by the Forest Department as Rs.14553/ year and calculated as 20 years = Rs.2,91,060/ (Rupees two lakhs ninety one thousand and sixty only) shall be paid in the name of the District Forest Officer, Dindigul.

As per the conditions stipulated in the G.O.(SI No.V) cited above an undertaking letter shall be given for payment of additional amount or NPV of the diverted forestland if any, becoming due after revision of the same by the Hon'ble Supreme Court of India in future shall be charged by the Forest Department.
