The Ministry of Environment Forests and Climate Change, Bengaluru has accorded 'in principle' approval (Stage-I) under Section-2 of Forest (Conservation), Act-1980 for establishing Downhill Pipe Conveyor (DPC) for Bhadra Iron Ore Mine M.L.No.2365 and Tunga Iron Ore Mine M.L.No.2366 in of M/s JSW Steel Ltd Torangallu in D.M Block Sy.No.1251 of Sandur Taluk, Ballari Dist. over an extent of 0.604 ha subject to conditions of approval mentioned therein. The same has been communicated by the Nodal Officer, FC Act 1980 vide letter number A5(1)/MNG/CR-9/2017-18 Dated: 01-02-2019 to this office for issuing demand notice and submission of a "Compliance Report.

As per the Principal Chief Conservator of Forests (HOFF), Bangalore order, regarding Compensatory Afforestation charges the revised to Rs.3,15,000/- per hectare as per Common Sanctioned Schedule of Rates (CSSR) in the year 2019-20. As per this revised rates, you are requested to make the differential payments shown hereunder.
