It is proposed to take up for Construction of High Level Bridge across Godavri on Medipally – Bornapally road at Km **30/8** in Karimnagar District. The Government have accorded administrative sanction for an amount of Rs.70.00 Crores vide reference 1st cited.

This road length is 30.800 Km single lane with B.T surface. Hence it is required to improve Widening to double lane in addition to constructing C.D works to have proper transportation facilities to the villagers.

The road is passing through forest reaches from Km. 22/0 to 22/6 Both sides and Km 23/8 to 29/0 Both sides The above forest reach is under the Forest jurisdiction of Karimnagar West Division..

The Telangana state Government have taken a policy decision to improve the roads from Single lane to Double lane. The Government have accorded Administrative sanction for an amount of Rs.70.00 Crores vide G.O.RT No.131T(R&B)R-II Dt:27.11.2014. Due to Widening and improvement of the above road would improve further connectivity in terms of achieving smooth and safe traffic flow and improve level of service. In addition to above, substantial economic gain in terms of reduced Vehicle Operating Cost (VOC) and reduced travel time will be achieved.

It is proposed to take up road widening along the existing road. As such the permission of the forest authorities is required. Hence proposal is submitted for diversion of forest land worked out to an extent of 11.30 hectares in Karimnagar West division.

A detailed Differential Global Position Survey is carried out in the above reach along with the forest section officers. As per our requirement the total extent of forest land is

arrived as 11.30 Hectares in Jurisdiction of Karimnagar Forest West Division, for which linear diversion of forest land is required.

The proposals are being submitted as per the guidelines issued under Forest (Conservation) Act 1980, the project for road construction will be processed in their entirety. Hence, the proposals for Acquisition of forest land is prepared in the Karimnagar West forest Division in the prescribed format, drawing showing the improvements, Longitudinal section and cross section along with forest map showing the area of land are herewith enclosed for kind perusal. Hence, I herewith submit the proposals under Forest (Conservation) Act, 1980 with the following enclosures.

It is, therefore, requested to arrange to initiate the process of forest land acquisition and also required to pass necessary orders to the concerned to start the field survey as early as possible for submitting same to the Government for according approval of linear diversion of forest land for geometrical improvements of road in reserve forest.

The ROFR certificate issued by the District Collector along with the enclosures shall be obtained and furnished to the DFO, Karimnagar West Division, for processing.
