

**JOINT VERIFICATION OF REVENUE NON - FOREST GOVERNMENT LAND FOR
COMPENSATORY AFFORESTATION FOR KUTULISINGA IRRIGATION PROJECT**

1. A joint Verification was conducted in the said patches for CA land of Kutulisinga Irrigation Project on Dtd : 25.11.20.
