## CERTIFICATE

REGARDING COMPLIANCE OF SCHEDULED TRIBES & OTHER TRADITIONAL FOREST DWELLERS (RECOGNITION OF FOREST RIGHT) ACT, 2006 IN RESPECT OF DIVERSION OF FORESTLAND MEASURING HC.63.901 IN VILLAGE JAJANGA & KHANDABANDH UNDER BARBIL TAHASIL FOR MINING ACTIVITIES IN JURULI IRON & MANGANESE MINES OF M/S TARINI MINERALS PVT LTD.

- 01. It is certified that the complete process for identification and settlement of rights under the Scheduled Tribes & Other Traditional Forest Dwellers (Recognition of Forest Rights) Act, 2006 has been carried out for the entire Forest area of **Hc.63.901** proposed for mining activities in village Jajanga & Khandabandh under Barbil Tahasil in respect of Juruli Iron & Managanese Mines of M/s Tarini Minerals Pvt Ltd under Barbil Tahasil. The concerned record of all consultations and meeting held are annexed in shape of Gram Sabha Resolution dt.06.09.2010 and 10.12.2010, joint enquiry report dt. 26.02.2011 of Revenue & Forest Personnel.
- 02. It is certified that the proposal for such diversion have been placed before the Gram Sabha at village Jajanga on 06.09.2010 at 10.30 and at village Khandabandh on 10.12.2010 at 10 A.M. under the Chairmanship of Sarapanch, Jajanga and Jalaharai G.P. resepctively and in presence of more than 60% of members of Gram Sabha where the details of the projects and its implication have been explained to them in vernacular and English language. It is further ascertained that no eligible Forest Dwellers was found under Forest Rights Act, 2006.
- 03. It is certified that discussions and decisions on such proposals had taken place only when there was quorum of minimum 50% of the members of the Gram Sabha present.
- 04. It is certified on the basis of joint verification report dt.26.02.2011 and Gram Sabha Resolutions dt.06.09.2010 and 10.12.2010 that no such primitive Tribal Groups and pre-agricultural communities were available on the forest land proposed for diversion and whose forest rights are required to be specifically safeguarded as per section 3(1) (e) of the Forest Rights Act, 2006.
- 05. It is certified on the basis of joint verification report and Gram Sabha Resolutions dt.06.09.2010 and 10.12.2010 that no such facilities managed by Government requiring diversion of forest land u/s 3(2) of the Forest Rights Act, 2006 exist over the forest land proposed for diversion.
