With reference to the subject cited (5) above, the Additional Principal Chief Conservator of Forests (Forest Conservation), Bengaluru has directed to issue Revised demand notice to the user agency as per reference No. (4) for payment of Net Present Value, Compensatory Afforestation and other charges. Hence, revised the demand notice issued for CA charges in revised rate to user agency for 4.388 ha. The Net Present Value is same as and Compensatory afforestation charges revised as below.

Therefore, you are hereby requested to make payments through e-payment module of forest clearance portal "forestclearance.nic.in" as directed by the Government of India as per the demand notice issued by this office by uploading the demand notice for acceptance to the Principal Chief Conservator of Forests (Head of Forest Force), Bangalore and after getting the challan generated from the said portal.


You are directed to comply the following conditions below.

1. Legal Status of forest land shall remain unchanged.
2. The demarcation of the common boundary of the forest area being diverted shall be carried out by erecting cement concrete pillars duly numbered at and interval of 20 meters at the cost of User Agency, before Stage-II approval.
3. The identified non-forest land over an extent of 4.388 ha in Sy.No. 266 of Halakurki village, Badami taluk, Bagalkot district for Compensatory Afforestation shall be transferred and mutated in favour of Forest Department. The mutation details shall be furnished.
4. The cost of Raising of Compensatory Afforestation over identified non-forest land shall be deposited by the User Agency.
5. Non-forest land for compensatory afforestation shall be notified by the state Government as RF/PF under Indian Forest Act 1972 or the State Forest Act within a period of 6 months from the date of issue Stage-II approval and Nodal officer (FCA) shall report the compliance.
6. Avenue planting shall be taken up by User Agency along the road on either sides wherever required at the project cost. The plantation shall also be maintained at the project cost. The user agency shall furnish an undertaking to this effect.
7. Additional amount of the Net Present Value (NPV) of the diverted forest land if any, becoming due after revision of the same by the Hon'ble Supreme Court of India in future shall be charged by the State Government from the User Agency. The user agency shall furnish an undertaking to this effect.
8. User Agency should ensure that compensatory levies are deposited through challan generated online on the web portal and deposited in appropriate bank online only. Amount deposited through other mode will not be accepted as compliance of the Stage-I clearance.
9. The total forest area utilized for the project shall not exceed 4.388 ha.
10. Any other condition that the Additional Principal Chief conservator of Forests (Central), Regional office, Bangalore may impose from time to time for protection, improvement of flora and fauna in other area and public convenience, shall also be applicable.
11. Violation of any of the conditions shall invite penal action, as deemed fit by the Additional Principal Chief Conservator of Forests (Central), Regional office, Bangalore.

After completion of the payments, you are directed to upload compliance report for the conditions stipulated in Stage-I approval dtd. 14-02-2018 issued by Deputy Conservator of Forest (Central) Bangalore and (4) sets of hard copies submitted to this office for further needful action.
