



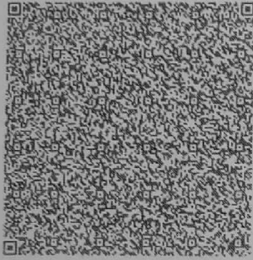

Company's Articles of Association and of powers enabling the company in that behalf doth hereby constitute and appoint

Nitin Agarwal - Manager (Projects)

J.K. Thakur - Head (Forest & Wildlife)

(hereinafter called of "the Attorney OR Attorney's") to be the true and lawful Attorney of the Company for and in the name and on behalf of the Company severally to do all or any of the acts and things with respect to 'Additional 400kV feed to Goa and Additional System for Power Evacuation from Generation Projects pooled at Raigarh (Tamnar) Pool' namely: -

- a. To make, sign, modify, file applications, letters and documents to the Forest & Wildlife Departments regarding Forest & Wildlife Clearances for establishing the above said transmission lines under the Forest Conservation Act, 1980 and other forest and wildlife laws and Acts as may be applicable, to complete all administrative and legal formalities in relation to the same.
- b. To interact, liaise, represent and deal with the Forest & Wildlife Officials as and when required for the said Forest & Wildlife Clearance for Transmission Lines and obtain all statutory permissions and approvals, if any.
- c. To do all such, acts, deeds, matters and things as may be necessary to deal with the Forest and Wildlife authorities for the aforesaid project.

AND IT IS HEREBY DECLARED that the Attorney in exercising the powers hereby conferred on him/them shall confirm to the regulations and directions for the time being imposed on or given to him/them by the Company **PROVIDED ALWAYS** that no person dealing with the Attorney shall be concerned to see or enquire whether he is or is not acting in accordance with such regulations or directions and notwithstanding any breach of such regulations or directions committed by the Attorneys in respect of any deed or instrument the same shall as between the Company and the person dealing with the Attorney be valid and binding on the Company to all intents and purposes.

AND the Company hereby ratifies and confirms and agrees to ratify and confirm whatsoever that shall be lawfully done by the Attorneys under or by virtue of these presents including in such confirmation whatsoever shall be done between the date of revocation hereof and the time of such revocation becoming known to the Attorneys.



In case any of the Attorney's ceases to be in the employment of the Company, then the rights to such attorney under this instrument will extinguish, forthwith.

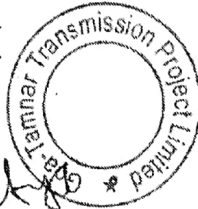
This Power of Attorney is valid till the time it is revoked or the employee ceases to be in the employment whichever is earlier.
