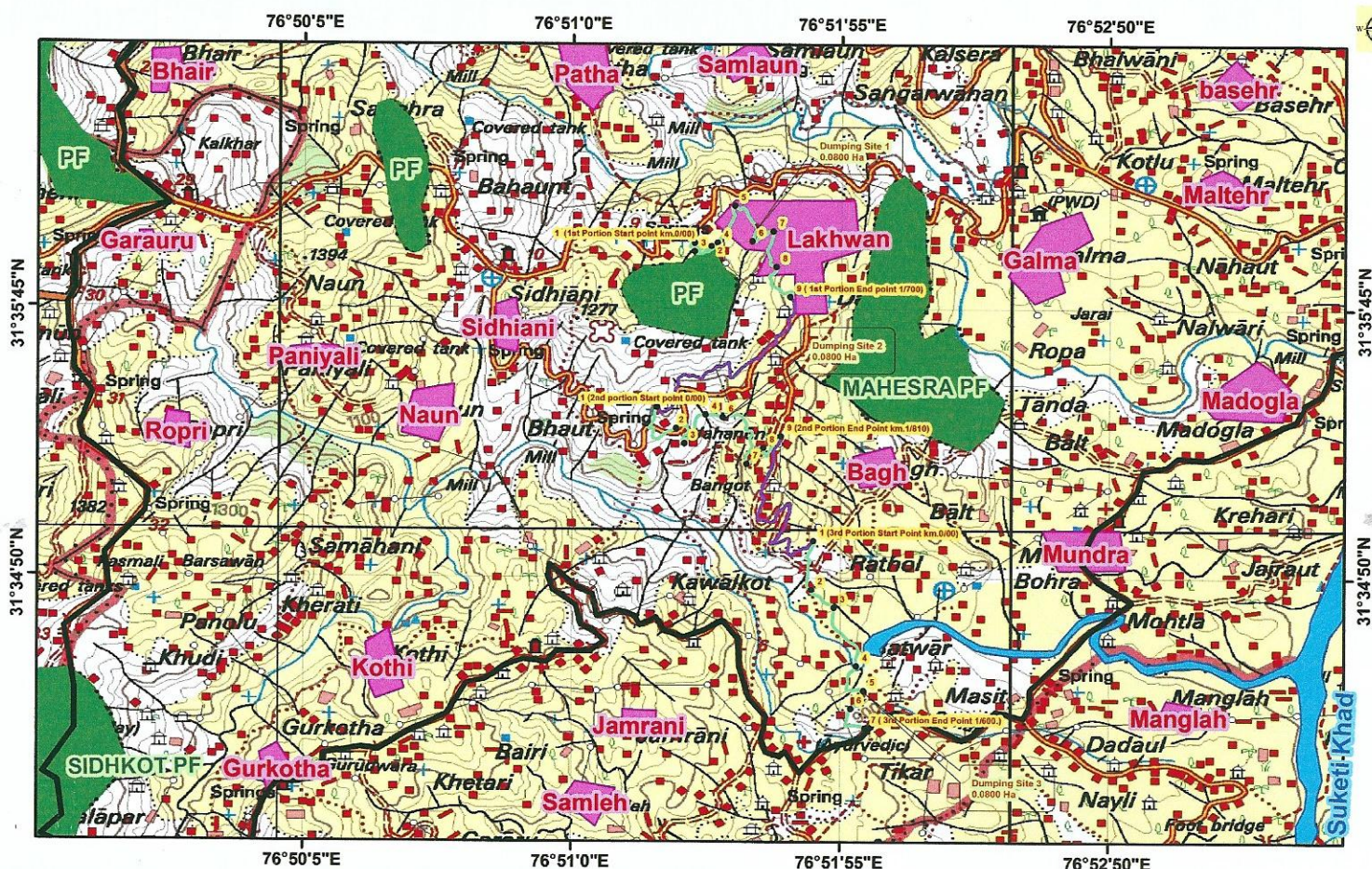


**TOPOSHEET MAP OF CONSTRUCTION OF LAKHWAN DAHANU HAWANU BHANGOT RATHOL
