Sub: Works to be taken up as per the Budget Assurance 2012 - 2013 and other works.

Requirement of Government approval and funds - Reg.


During the 114th Board meeting held on 8th November 2012, agenda items were placed before the Board for taking up various new projects by GSIDC as per the Budget Assurance 2012-2013 and various other works taken up/ to be taken up and regarding Government approvals. Subsequently, a meeting was held with the Hon'ble Chairman, GSIDC/Hon'ble Chief Minister in the presence of Chief Secretary, Government of Goa and Joint Secretary (Finance). In the meeting, it was decided that the GSIDC should take up the projects based on priority and schedule given by the Finance Department. Accordingly, the list of projects has been forwarded to the Finance Department for prioritizing the projects.

A meeting was convened by the Hon'ble Chairman, GSIDC/ Hon'ble Chief Minister on 2nd January 2012 and following officers were present (i) Joint Secretary (Finance) (ii) Additional Secretary (DMU) (iii) Managing Director, GSIDC, wherein, it was decided to seek approval to take up the following projects on priority:-

1. Construction of Shiroda - Rachol Bridge. ✓
2. Construction of bridge at Chodan to Pomburpa. ✓
3. Construction of bridge at Betim to Panaji. ✓
4. Construction of bridge at Virdi to Amona. ✓
5. Construction of third phase of Panaji Market. ✓
6. Construction of bridge at Camurlim to Tuem. ✓
7. Construction bridge at Keri to Terekhol. ✓
8. Construction of bridge at Madkai to Neura. ✗

Details of project cost (approximate) and tentative funds required for the current financial year and the three financial years is placed at C/1. It was also decided in the meeting to explore the possibility of NABARD loan for the projects at Sr. No. (1), (2) and (3). On approval of the projects by the Finance Department, consultants for the project from the empanelled list of GSIDC under appropriate category could be appointed by following the standard bidding procedure of GSIDC and Detailed Project Report (DPR) may be prepared.
