### ❖ Name of the Project

Proposal for diversion of Forest land for approach road , with underground electric line and drinking water supply line on either side of road, from forest S no 39 at village Katraj , Tal.- Haveli to school constructed in survey no 10 /2/1 at village – Gujar- Nimbalkarwadi, Tal. –Haveli from, Dist.- Pune. Proposal for diversion of forest land for approach road under section 2 (ii) of Forest (Conservation) Act, 1980. Forest land required is 0.108 ha. from Forest S. no 39 at village- Katraj, Tal. - Haveli, Dist.- Pune.

*Forest area required 0. 108 Ha. Only*

### ❖ INTENTION & FACT OF THE PROPPSAL

The proposal submitted by, Shri Uday S. Mulik, Chairman, Dyane Vikas Prathishthan, Kondhawa., Pune. for diversion of Forest land for Construction of approach road & laying of underground electric light & drinking water supply pipe line on either side of road to Creative English Medium School at Gut no 10/2/1B at Gujar-Nimbalkarwadi through forest land S. no 39 at Katraj Tal.- Haveli, Dist. – Pune, for non-forest purpose. Forest land required is 0.108 ha. The approach road required for School. Forest land required ia 0.108 ha.

The survey no 10/2/1B at Gujar- Nimbalkarwadi, has adjoining to forest land. There is pack track passing from forest S. no 39 at Katraj, Tal. Haveli, Dist. –Pune. Hence there is no approach road facility to enter in private S.no 10/2 at Gujar- Nimbalkarwadi, Tal.- Haveli, Dist. –Pune.

Forest land required for approach road come under the purview of the provisions of the Forest (Conservation) Act, 1980,

making it incumbent on the State Government to obtain prior approval of the competent Govt. Authority, under the provision of the said Act.

### ❖ COST OF THE PROJECT:

Cost of construction of Kutchha road works on forest land & private is approximately Rs7.06 Lakhs. Permanent 10 to 15 persons/years and temporary average 700 MD/ per Year employments generated during the works of road

### ❖ Justification for proposal

The proposal for diversion of Forest land for Construction of approach road & laying of underground electric light & drinking water supply pipe line on either side of road to Creative English Medium School at Gut no 10/2/1B at Gujar-Nimbalkarwadi through forest land S. no 39 at Katraj Tal.- Haveli, Dist. – Pune, for non-forest purpose. Forest land required is 0.108 ha. The approach road required for School. Forest land required is 0.108 ha.

The survey no 10/2/1B at Gujar-Nimbalkarwadi, has adjoining to forest land. There is pack track existing passing from forest S. no 39 at Katraj, Tal.- Haveli, Dist. –Pune, Hence there is no approach road facility to enter in private S.no 10/2 at Gujar- Nimbalkarwadi

Gujar-Nimbalkarwadi, Tal.- Haveli, Dist. Pune This school has been sanctioned by the Dy. Director of Education M. S. Pune by letter no 16887 /2016 dated 27<sup>Th</sup>. July 2016. The The private land Gut no 10/2/1B is leased by Dnyan Vikas Prathishthan Trust Kondwal Bk. & the lease deal has been registered at Sub-Register Haveli 20 by register no 6609 /2015, dated 3.11.2015. The lease period is 33 years from year 2015.


Private land Gut no 10 at village Gujar Nimbalkar wadi, Tal. - Haveli, is adjoining to the forest Survey no 39 at Katraj , Tal. Haveli. There is no other alternatives other than proposed road. hence P.A. has submitted proposal under forest (conservation) Act, 1980

So Proposal is made for diversion of 0.108 ha. Forest land required for approach road including laying of electric & drinking water supply line on either side of road. Which will be made pakka cement concrete road after sanction under F. C. Act, 1980

The Project Authority is aware for uses of Forest land for non-forest use, prior approval is required under Forest (Conservation) Act, 1980 from Central Govt. Project Authority has not started work in forest land and also in Non-Forest land. P. A. will start work after sanction by State Govt. Hence this proposal is being submitted for necessary approval under the provision of the u/s 2 (ii) of forest (conservation) Act,1980
