(D-i) Justification for locating the project in forest land and details of alternates examined

User agency have proposed diversion of reserved forest land 3.30 ha for non forestry use under Section 2 of Forest (Conservation) Act, 1980 for renovation of existing Kanifnath , other temples, buildings and development works project at Village- Bopgaon, Taluka -Purandhar , District-Pune within premises of Shri .Kanifnath Tirth kshetra is existing ancient temple at Bopgaon.

Shri .Kanifnath Tirth kshetra is existing ancient temple with many small temples and buildings kitchen, water tanks, Toilet blocks, steps, roads etc. were constructed on forest land prior to more than 300 years and the forest land is under vahivat (other rights) of temple authority since old age and various religious temple festivals are being celebrated throughout the year.Shri .Kanifnath Tirth kshetra was established over top of hills on small forest land and there is non availability of adequate basic infrastructure. On important occasions number of problems are generated causing hardships, inconveniences to devotees and management committee of Trust

Certificate about no suitable alternate not- forest land is available other than proposed forest land and demand for the forest land is minimum by Sub-Divisional Forest Officer Bhor and Certificate bout all other alternate, for the purpose have been explored and that no suitable alternate not forest land is available for the purpose and demand for the required forest land is lowest minimum demand for the same by project authority is enclosed with the proposal.
