- v. While tendering the e-challan at the bank, the agency must ensure that the unique account number mentioned in the challan should be correctly mentioned as the account number in which funds to be remitted.
- vi. Upon executing the RTGS by the sender/remitter bank, the amount collected will be credited to relevant CAMPA State account with the Bank on real time basis.
