NOTE CONTAINING JUSTIFICATION FOR LOCATING THE PROJECT IN REVENUE FOREST LAND AT VILLAGE MAHUPAL BARAI DISTT. BASTAR.

The Proposal to Establish 220/132/33 KV sub- station at Jagdalpur Vill. Mahupal Barai is Approved by Honourable Electricity Regulatory Committee (C.G.GOVT.) in respective of providing uninterrupted & better quality electricity to Jagdalpur & nearby areas which is in Left Wing Affected Bastar distt. This Project will also Provide Electricity to Up coming Industries in the Area.

In Present Senerio Power Supply to Jagdalpur & nearby areas is through 132/33 KV feeders, hence interruption & losses are much more. This Project will help to overcome all the short comings of 132/33 KV lines & can also provide employment to the local workers during Construction.

Proposed Land is best located in the side of 400/220 KV sub station. The 132 KV Kondagaon Jagdalpur line is very near to proposed site of 220/132/33 KV Sub station due to which LILO of the line can be done at low cost. The 220/132/33 KV Sub station Jagdalpur will be energised by extending 220 KV main and auxiliary buses of 400/220 KV Sub station hence no inter connecting 220 line will be needed. Since the control and monitoring of 220/132/33 KV Sub station will be integrated in 400/220 KV Sub station there will be saving in control room building, station transformer for C.S.P.D.C.L. supply, battery, battery charger, ACDB/DCDB exchange, 220 KV bus coupler and 220 KV bus transfer bay also.
