It is to inform that, vide reference 4<sup>th</sup> cited the Ministry of Environment, Forest and Climate Change Government of India. Regnal Office Chennai has conveyed in-principle(Stage-I) approval under section 2 of Forest Conservation Act,1980 for Diversion of 62.5749 (revised from 62.25 Ha) (Asifabad Division-16.5099 Ha) of forest land for construction of four laning of NH-363 Hyderabad-Karimnagar- Chanda Road from Km 0.000 (Km 251.900 ) to Km 94.602 (342.000)- In favor of DGM (Tech.) & Project Director, NHAI, PIU Nirmal, subject to the compliance of the certain conditions mentioned therein, which was communicated vide reference 5<sup>th</sup> cited to raise the demand notice over the user agency for payment of compensatory levies after vetting by the Nodal Officer (FCA) and also to obtain the compliance report from the user agency and furnish for onward submission to Government for obtaining the stage-II(Final) approval.

In view of the above, the demand notice has been prepared and furnished by respective Forest Divisional Officer, Asifabad vide reference 8<sup>th</sup> cited, which has been returned through mail by the APCCF (FCA) on 24.04.2019 to attend to certain shortcomings.

Accordingly, the revised demand notice was submitted on 24 04.2019 for vetting, the same is accepted by the Addt. PCCF (FCA) O/o Prl.CCF, Telangana Hyderabad on 24.04.2019 through mail.

In this regard, the demand notice issued to the User agency vide reference 11th cited and requested to submit the condition wise compliance report with specific remarks on (Stage-I) approval along with remittance particulars of demand notice and furnish required undertaking certificates /connected documents and copies of Paper clippings about the publishing of forest Clearance etc., for onward submission to the Higher officers for obtaining Stage-II approval.

It is to inform that, the Principal Chief Conservator of Forests (HoFF) Telangana, Hyderabad vide reference 12<sup>th</sup> cited has stated that, the Forest Divisional Officers/ District Forest officers of Mancherial, Bellampally and Asifabad have issued the demand notices for raising of Avenue and road median plantations for an amount of Rs.1,49,33.429/- in Mancherial Division, Rs.76,78,800/- in Bellampally Division and Rs.2,63.96.800/- in Asifabad Division. The Project Director requested to exempt for payment towards raising and maintenance of (7-10) years of strip plantation on either side of the road and also on central verge and also give under taking that "NHAI undertake to take up the strip plantation (Avenue plantation) on either side of the road and also on the central verge (median plantation) and will be maintained for seven years to ten years at the project cost". The request of the PD, NHAI, PIU Mancherial is examined and the undertaking is accepted and requested to take necessary action accordingly for revision of Demand Notice and submission to Nodal Officer (FCA) for final approval. In the demand notice, the Adhoc CAMPA Account numbers shall not be mentioned.

In view of the above, the Revised demand notice of Asifabad Division (16.5099 Ha) submitted for vetting vide reference 13th & 14th cited. The revised demand notice was accepted by the Principal Chief Conservator of Forests (FCA)/Nodal Officer O/o Prl.CCF, Telangana Hyderabad on 03.08.2019 vide reference 15th cited.

Further it is informed that, the User agency is requested to deposit the following mandatory Revised demand notice amount is as follows and requested to go through the references carefully and fulfillment all the conditions stipulated in the reference 4<sup>th</sup> and 5<sup>th</sup> cited and report compliance.

The User Agency is requested to comply with the following in accordance with the MoEF &CC. GoI instructions issued vide F,No.7-23/2012-FC, Dt.24.07.2013 communicated vide PCCF's Rc.No.45921/2001/F4, Dated.23.08.2013 and publish the orders at the cost of the project proponent.

- Publish the entire forest clearance granted in verbatim along with the conditions and safe-guads imposed by the Central Government in two widely circulated daily newspapers, one in vernacular language and the other in English granted to the project proponent for use of forest land for non-forest purpose.
- The copies of the Forest Clearance should also be submitted to the Head of local bodies, Panchavats and Municipal Bodies by the project proponents in addition to the relevant offices of the Government who in turn has to display the same in 30 days.

This in-principle approval shall be valid for a period of 5 years from the date of issue of this letter. In the event of non-compliance of the above conditions, this in-principle approval shall automatically stand revoked after 5 years.

The transfer of forest land to user agency shall not be effected prior to the issue of final approval (or) working permission whichever is earlier.

Therefore, the User agency is requested to submit the condition wise compliance report with specific remarks on (Stage-I) approval along with remittance particulars of revised demand notice and furnish required undertaking certificates /connected documents and copies of Paper clippings about the publishing of forest Clearance etc., as called in this case urgently for onward submission to the Higher officers for obtaining Stage-II approval.

The User agency is also requested to furnish the RoFR certificates comply the following in accordance with the MoEF&CC, Gol instructions as per F.No.7-23/2012-FC, Dt.24.07.2013
