You are requested to comply with all the Conditions and submit your point-wise comprehensive compliance for onward transmission to the Govt. at the earliest.



1. The User Agency is requested to deposit ₹ **2,04,400/-** (₹ 7,30,000/- (X) 0.28 ha.) (Rupees Two Lakh Four Thousand Four Hundred) only towards Net Present Value (NPV) pertaining to 0.28 ha. of entire forest land as per **Condition No.(iv)** of the Stage-I approval order within 30 days from the issue of this Letter.
2. The User Agency is requested to deposit ₹ **1,00,532/-** (₹ 82,000/- (X) 1.226 ha.) (Rupees One Lakhs Five Hundred Thirty two) only towards Regional Wildlife Management Plan fund pertaining to Bonai Division as per **Condition No.(vii)** of the Stage-I approval.




