- The User Agency is requested to deposit ₹ 1,00,532/- (₹ 82,000/- (X) 1.226 ha.) (Rupees One Lakhs Five Hundred Thirty two) only towards Regional Wildlife Management Plan fund pertaining to Bonai Division as per Condition No.(vii) of the Stage-I approval.
