The Power Department has allotted the Meenvallom project vide G.O.(MS) No.5/2011/PD Thiruvananthapuram, Dated 14.02.2011 of Power(B) Department. The Project is implemented by the Palakkkad Small hydro Company Ltimited, a company promoted by District Panchayat, Palakkad. The District Panchayat Palakkad has requested the Power Department, Government of Kerala for allotting the Palakkuzhy 1 MW Palakkuzhy Project for implementation through Palakkad Small Hydro Company Limited.

The Project proposes to utilize the Water flowing down the Palakkuzhy stream at Thendillam Waterfalls and generate power at 1 MW capacity and 3.78 million units (MU) annual generation. The proposed generation of power is without affecting the socio economic parameters of the locality since it is a run off the river scheme using the excess water flowing during monsoon, the river will not go dry and the life of the local population will not be affected. There is no danger to life and sustainability of wild animals and the adjacent forest area.

Small Hydroelectric projects are site specific and utilizes the Head of the water stream. The project cannot be relocated to another area. The present location which was identified after detailed study by Kerala State Electricity Board and other Government departments is ideally suitable for the project. The diversion of Forest land is negligible (0.3 Ha) and is kept at minimum. The 300 M length and 10 M width land required for the project for laying penstock pipe is across the forest land in North - south direction of Block No.39 of vested Forest item No.37/4 in R.S.358 of Kizhakkanchery village No.2.

The construction of penstock is the only component of the project which crosses the forest and all other components like weir, Power House, Tail race, Low pressure pipe etc. are situated in Private land are registered in the name by Palakkad Small Hydro Company Limited at Sub Registrar Office, Wadakkencherry.

The construction of the Project can be started as and when the proposed forest land is transferred on lease to the Palakkad Small Hydro Company Limited.
