With reference to the subject cited, the work Widening and Strengthening of PWD Road to Yadaram from km 0/0 to 7/600 in Medchal-Malkajgiri District is proposed to widen the road from 3.66 mts to 7.00mts (10 mtrs including shoulders). A portion of this road is passing through the forest land in the stretch of Km 4/040 to 5/008 i.e. for a length of 967.797 mts (Area of the road 0.968 Ha) in between Rajbollaram thanda to Yadaram village, Shamirpet Mandal,Medchal-Malkajgiri District.
