Sub: Grant of Mining Lease in the district of Keonjhar.

Read: Application presented on 26.9.94 by M/s OMC Ltd. for grant of Mining Lease over an area of 494.24 hec. in Village-Balda, Mahaparbat & Unchabali in the district of Keonjhar for Iron Ore.

Order

Whereas M/s Orissa Mining Corporation Ltd. have applied to the state Government for grant of a Mining Lease by their application read above;

Whereas the mineral in the land in respect of which the Mining Lease has been applied for belongs to Govt. and the land is at their disposal;

Whereas the applicant(s) being a Limited Company is incorporated or registered in India;

Whereas the applicant(s) by themselves or with any person joint in interest with them do not in respect of Iron Ore or related group of minerals held such area in the State as with the area over which the M.L. has now been asked for will exceed ten square kilometres in the aggregate;

Whereas the Govt. of India in their letter No. 5/34/98-MIV(ii), dt. 3.6.99 have conveyed their approval to the grant of M.L. Under Section-5(1) and 6(1)(b) & 6(1)(c) of the M.M. (D&R) Act, 1957 over 77.00 hec.;

Whereas the party was asked in this Department letter No. 3195, dt. 27.3.2000 to accept the terms & conditions under which the M.L. was proposed to be considered for grant and the party in their letter No. 7127/OMC/2000, dt. 10.4.2000 accepted the conditions but subsequently intimated vide letter No. 285/OMC/2000, dt. 19.9.2000 to retain 68.00 hec. in Block-A

The Govt. are hereby pleased to order that a Mining Lease in respect of the area over 68.00 hec. in Village-Unchabali, Nayagarh and Balda in the district of Keonjhar be granted to M/s Orissa Mining Corporation Ltd. for a period of 20 (twenty) years for Iron Ore subject to the conditions laid down in the State Govt. letter No. 3195, dt. 27.3.2000. The party should comply with all the terms and conditions including furnishing of a surveyed map and description within 6 months from the date of this order to the Collector, Keonjhar subject to the condition that the party will submit revised mining plan approved by I.B.M. before execution.
