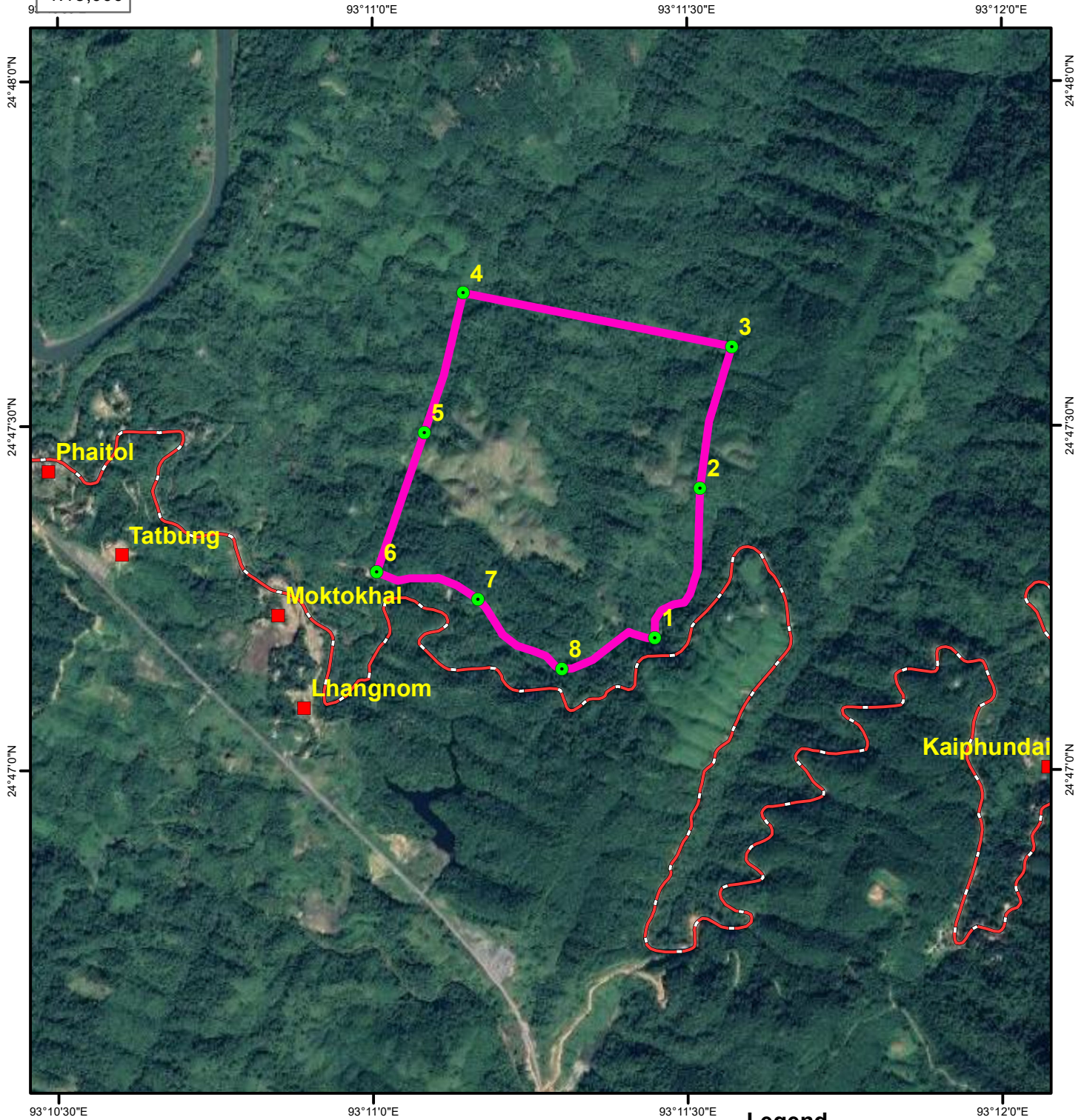
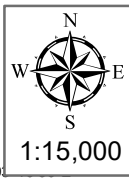


**Map showing proposed CA Plantation site for

Imphal-Jiribam Road Section of NH-37 (NH-53) into two laning.**

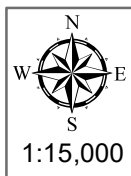

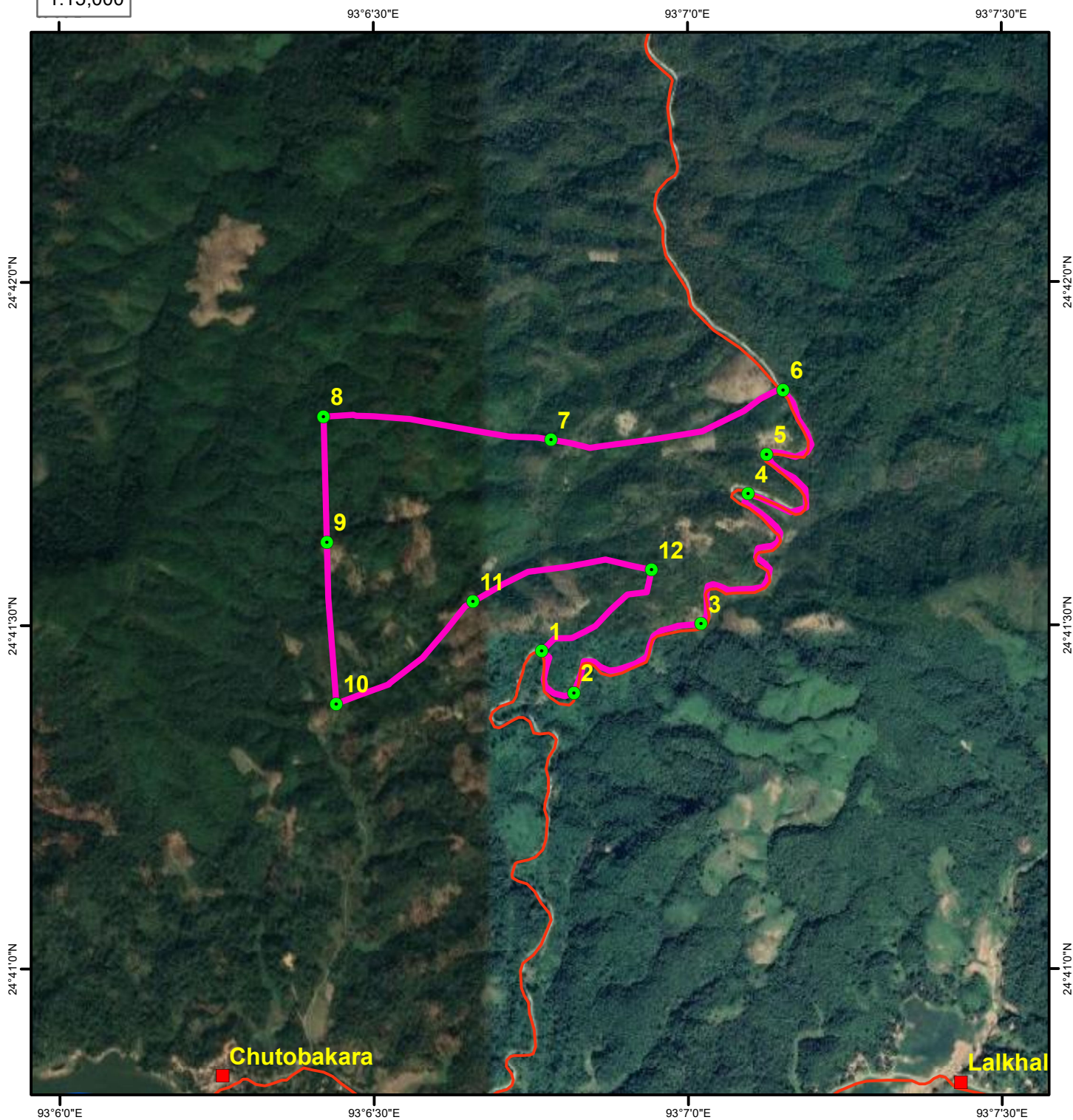

Imphal-Jiribam Road Section of NH-37 (NH-53) into two laning.**

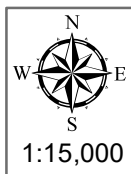

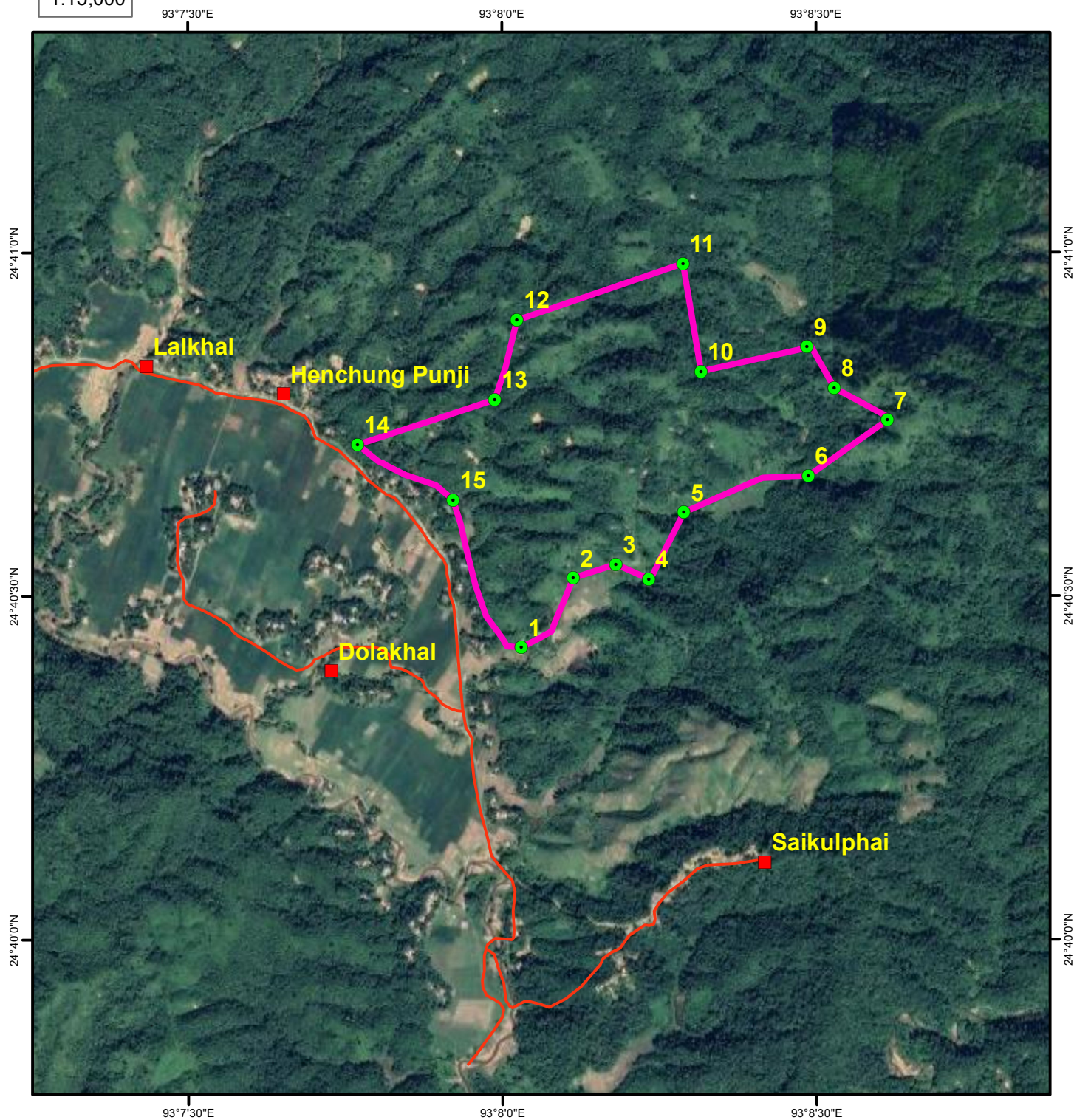
