**Sub: Forest Clearance Proposal regarding Construction of 132 KV S/C Biharsharif- Sheikhpura (New) transmission lines under Phase-IV part – I of the Bihar State transmission system strengthening & development programme .**

Sir,

For strengthening of power transmission network in State of Bihar, Bihar State Power (Holding) Company Limited and Power Grid Corporation of India Limited have formed A Joint Venture Company in the name of Bihar Grid Company Limited (BGCL) on 50:50 Equity Participation Basis. Accordingly, BGCL had been issued the requisite Transmission license under Section 14 of Indian Electricity Act'2003 by Bihar Regulatory Commission and authorization conferred by Govt. Of Bihar for laying of transmission lines under section 68 & 164 of Indian Electricity Act'2003 for transmission scheme covered under Phase-IV Part-I and Part-II.

As a part of the scheme, BGCL is constructing a 132 KV S/C Biharsharif - Sheikhpura (New) transmission line. The mention line is being constructed on approval from Govt. of Bihar. The above lines are routed through the private and Govt. lands of district Nalanda, Bihar. While planning and surveying the line route, great emphasis is given on Forest and Environmental aspects and no Forest land is involved in entire line corridor. However some plantation on road sides maintained by Forest deptt. On the land of NHAI could not be avoided at some places.

For the above, we have identified and marked such land on 1: 50000 Topo Sheet map of Survey of India. The list of Roads/River along with details of trees and area coming in line corridor have been prepared and enclosed herewith for your kind reference. All required documents in this regard are enclosed herewith for your kind perusal and necessary action at your end for forest clearance.
