With reference to opening of technical & financial bid under reference and your bid submitted to CE(NHDP-IVA), MoRT&H, New Delhi for above mentioned project, it is hereby informed that Competent Authority has accepted the offer given by M/s. Gayatri Projects Ltd, Hyderabad for an amount of Rs 306,00,00,000/- (Rupees Three Hundred Six Crores only) for the work of Rehabilitation and up-gradation of NH-4 from Km 133.36 to Km 171.59 (Andhra Pradesh/Tamilnadu border to Nalagampalli village) to Four lane with paved shoulder in the State of Andhra Pradesh under NHDP -IV on EPC basis Contract being the lowest bidder.

2. Accordingly, you are requested to ensure the followings within stipulated time:


- (i) To sign and return the duplicate copy of the LOA in acknowledgement thereof, within 7(seven) days of the receipt of the LOA as per clause 3.3.4 of RFP.
- (ii) To deliver to the Authority (NHAI), a legal opinion from your legal counsel with respect to the authority of the selected bidder to enter into this Agreement and the enforceability of the provisions thereof, within 10 (ten) days of the date of issue of LOA.



- (iii) To execute the Contract Agreement and to sign integrity pact with NHAI within 15 (fifteen) days of the date of issue of LOA; and
  - (iv) To provide to the Authority i.e. NHAI within 10 (ten) days of the date of this Agreement, an irrevocable and unconditional guarantee from a Bank in the form set forth in Schedule-G (the "Performance Security") for an amount equal to 5.00% (Five percent) of the Contract Price as per article 7.1.1 of draft EPC Agreement under intimation to the Ministry.
3. Any delay in submission of relevant documents/submissions/actions as mentioned in para 2 above may invite suitable action as per RFP/bid documents.
  4. The contract will be governed by the conditions of contract as noted in the tender documents/bid documents.
