In inviting a reference to the above cited correspondence on the subject this is to inform you that the Principal Chief Conservator of Forests (Wildlife) & Chief Wildlife Warden, Odisha has approved the Site Specific Wildlife Conservation Plan with a financial outlay of Rs.535.715 lakhs for implementation in the leasehold as well as surrounding area of Rayagada and Kalahandi district as per additional conditions imposed by Govt. of Odisha, F & E Department in their letter No.10F(Con) 2/2017- 14843/F&E dated 15.07.2017 and Stage-I approval accorded by Govt. of India, MoEF & C.C. in their letter No. order F.No.8-46/2016-FC dated 17.04.2017 for diversion of 233.343 ha of DLC forest land including safety zone of 10.283 ha in village Paik-kupakhal, Dhuturapass and Karanj-kupakhal under Kashipur Tahasil of Rayagada district within mining lease area of 1388.74 ha for bauxite Mining in the Baphilimali bauxite Mines in Kalahandi and Rayagada district of Odisha by M/s UAIL. 
