



New lane will be constructed on either side of existing road which will require new additional space of (As per Annexure-2) 0.99 hectare.


This R.O.B. is the important link from Bhalej-Anand-Umreth-Dakor-Sevalia-Godhra Road with connect Anand District with Panchmahal District and carries traffic of sourest to Gujarat, Maharashtra, Madhya Pradesh and South India.


