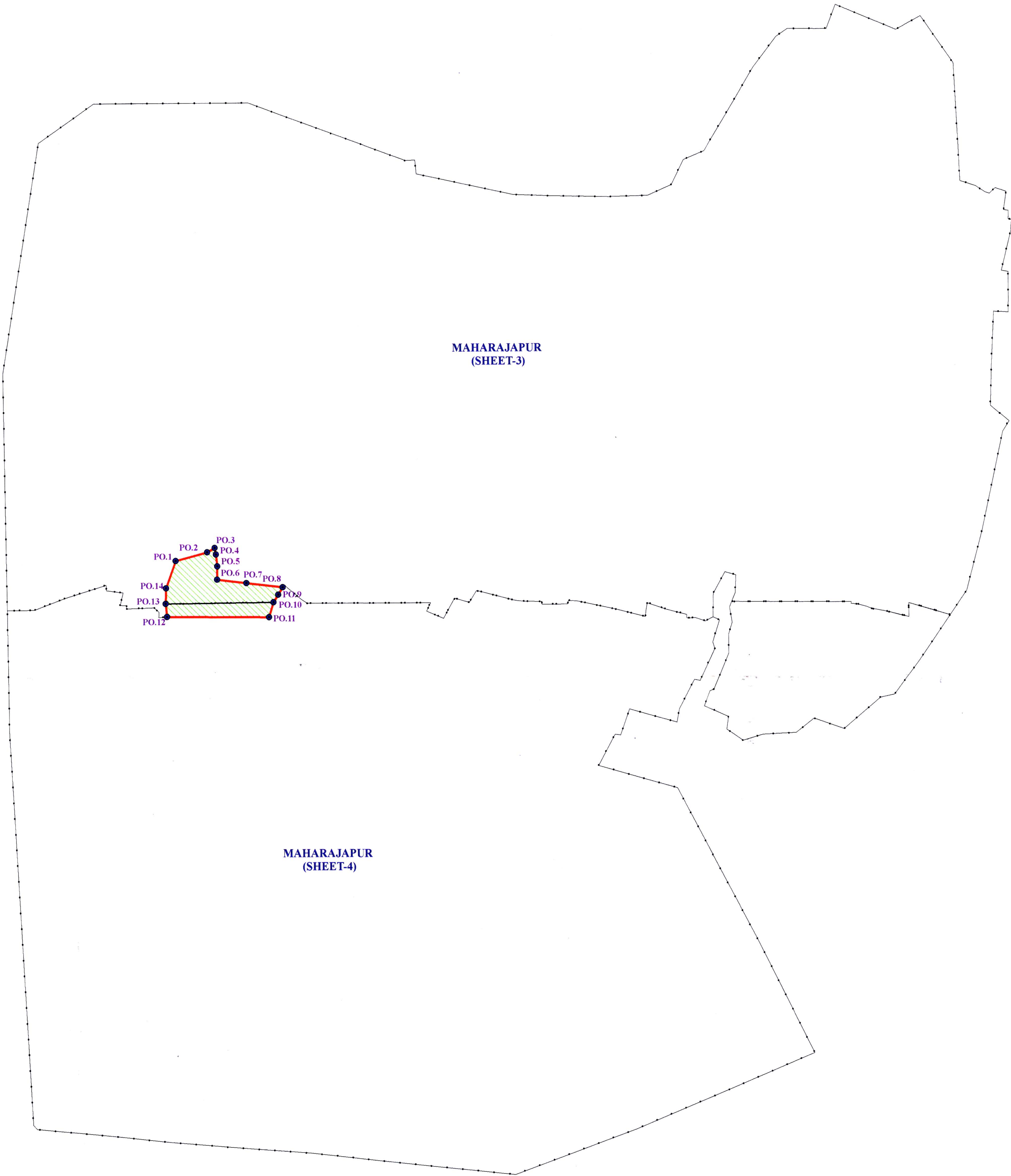
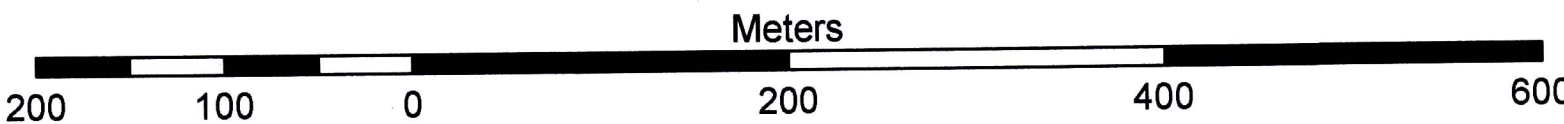

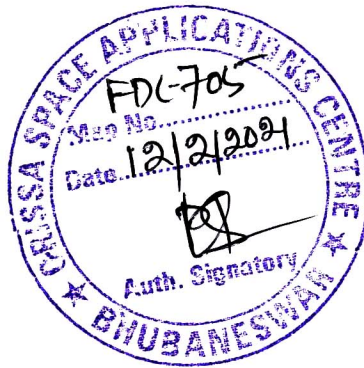

DGPS Survey of forest areas proposed for diversion within the project area of Mayurbhanj College of Accountancy & Management in Mayurbhanj district has been carried out by the Secretary, MCAM, Baripada through M/s Maptech Solutions Pvt. Ltd., Bhubaneswar, Odisha.

DGPS survey co-ordinates are verified by ORSAC. Also map showing forest areas proposed for diversion are verified with georeferenced cadastral sheets and surveyed points and compared with ortho rectified Cartosat satellite image and found that maps are correct at a confidence level of 95%

Total forest areas proposed for diversion comes under Revenue Forest category in Maharajapur village (Plot nos. 512 & 786) and works out to 0.894Ha. from the submitted .shp files against the allotted area of 0.890Ha (2.2Ac.).
