Justification for Proposed Forest Land

The district road plan for year 2001 to 2021 has been sanction by State Govt. There is kachcha road joining SH 121 Baramati – Indapur road to Nimgaon Ketaki- Bijawadi road (MDR 159) (Village road no 3). This approach road is in charge of Z. P. Pune for repair & maintenance.

This proposed road joining SH 121 Baramati –Indapur road to Nimgaon Ketaki- Bijawadi road (MDR 159) (Village road no 3) was in use by the local farmers and nearby villages to travels to Sugar factory at Bijawadi. And also N H 9 .Pune Solapur Road. This proposed road totally passing through the forest land of Village Gokhali , Tarangwadi , Tal. – Indapur, Dist.- Pune .

The forest land in Pune Forest Div. was transfers to Revenue Dept. by Govt. of Maharashtra Order no 8030 /1902 Dt 17.11.21902 for management Purpose & this forest land again transferred from Revenue Dept. to Forest Dept. in year 2009 by making Panchanama in Jun 2009 in presence of F. G Indapur and Talathi Gokhali. The forest area of village Gokhali & Tarangwadi has been notified as reserved forest under section 19 of Indian Forest Act , No VII of 1878 by notification no 7464 dt. 14/9/85. The proposed road will reduce distance to approach Sugar Factory at Bijawadi.& reduce distance of 10 to 12 Km. which save time and money of village peoples. This road will become useful to farmers of villages of Nimgaon Ketaki. Tal. Indapur

As this road totally passing through the forest land and villages are using this road from long back. But not shown on toposit map. So for repairs and maintain the road, there is need to take prior approval from Forest Dept.

As the above conditions to use of forest land to use approach road need to prior permission from the Central Govt.
