- Sub- Diversion of 0.2260 ha Reserved Forest Land in favour of Divisional Forest Officer, Mumbai Mangrove Conservation Unit, Mumbai for Development of Mangrove Conservation Centre and Mangrove Park at Village Gorai Tal. Borivali, in Mumbai Suburban District in the State of Maharashtra- Regarding.

With reference to above letter, requesting revised Demand Note for compliance of conditions of Stage-I Clearance mentioned in government of India's letter. User agency is required to pay following amount for fulfilment off condition no. 2(a), 3.

2. Compensatory Afforestation

(a) Compensatory afforestation shall be taken up by the Forest Department by planting 100 numbers of mangroves or ten time number of mangrove getting trimmed, whichever is more at the cost of the user Agency. As far as possible, a mixture of local indigenous species shall be planted and monoculture of any species may be avoided.

Condition

3. The Cost of Compensatory afforestation at the prevailing wage rates as per compensatory afforestation scheme and the cost of survey. Demarcation and creation of permanent pillars if required on the CA land shall be deposited in advance with the Forest Department by the Project authority. The CA will be maintained for 10 years. The scheme may include appropriate provision for anticipated cost increase for works scheduled for subsequent years.

Compliance

User agency required to pay following (A) and (B) amount in Ad-hoc CAMPA through E-challan in the Saving Bank Account for compliance of conditions no. 2(a), 3. Details as follows.

A) Cost of Compensatory Afforestation Scheme including cost of fencing of CA at the prevailing wage rate at the time of planation and maintenance for 10 years amounting Rs. 4,93,800/- (Four Lakh Ninety Three Thousand Eight Hundred only) and the other cost including 100 no. of additional plantation.

4. NPV

(a) The State Government shall charge the Net Present Value (NPV) for the 0.2260 ha forest area to be diverted under this proposal from the User Agency as per the orders of the Hon'ble Supreme Court of India dated 30/10/2002, 01/08/2003, 28/03/2008, 24/04/2008 and 09/05/2008 in IA No. 566 in WP (C) No. 202/1995 and as per the Guidelines issued by the Ministry vide letters No.5-1/1998-FC (pt.II) dated 18/09/2003, as well as letter No. 5-2/2006-FC Dated 03/10/2006 and 5-3/2007 FC dated 05/02/2009 in this regard.

B) User agency is required to pay Net Present Value for 0.22.66 ha. of Mangrove Forest Land to be diverted amounting Rs. 2,12,214/- (Two Lacks Twelve Thousand Two Hundred and Fourteen only).

User agency has submitted the undertaking mention that in future if Additional NPV or if any penalty is required to be paid by user agency.

(05) Cost of tree felling.

User agency should be deposit Tree Felling /trimming cost Rs. 25,000/- (Twenty Five Thousand Only) in following bank Account of Divisional Forest Officer, Mumbai Mangrove Conservation Unit Office through RTGS/DD/NEFT.
