It is to inform that, the Government of Andhra Pradesh in the reference cited, has accorded stage-I approval for diversion of 1.54 Ha. of Forest land in Compartment No.155 E.D.Pally R.F.,Kunavaram Range of Chintur Division for formation and providing BT to the road from Vinayakapuram to Irkampeta in favour of Executive Engineer, PR(PIU) Division, Kakinada by duly stipulating certain conditions to be complied as communicated by the Pri. Chief Conservator of Forests, A.P., Guntur vide reference cited( copies enclosed).

Inview of the above, the Executive Engineer, PR(PIU) Division, Kakinada is hereby requested to deposit the following mentioned amounts towards, Net Present Value(NPV) etc., through e-payment mode as per the guidelines issued by the Ad-hoc CAMPA, New Delhi letter dated: 09-06-2016 and the details are as follows:-

Amount demanded to be deposited in Adhoc CAMPA, Corporation Bank, Lodhi Road, New Delhi through e-payment mode i.e., challan generated through the Ministry's web portal(i.e. [www.parivesh.nic.in](http://www.parivesh.nic.in)) only (As per IGF, Ad-hoc, CAMPA Lr.No.12-2/2010-CAMPA, dated: 09-06-2016 communicated vide PCCF's Rc.No.45921/2001/FCA-4 (i), dated: 04-07-2016).

**I(a) Procedure for e- challan generation:**

- On issue of this notice, the user agency shall log into Forest Clearance portal [forests.clearance.nic.in/www.parivesh.nic.in](http://forests.clearance.nic.in/www.parivesh.nic.in) to generate e-challan and make payment against the demand.
- Agency shall fill all the details as per the format provided in the portal and submit to Nodal Officer for verification.
- Once it is verified by Nodal Officer, Agency can generate e-challan from the portal.

### I(b) Procedure for Payment through RTGS :

- iv) For payment through RTGS, the representation of the agency should visit his bank branch (RTGS enabled) of a Bank of his choice along with printed e-challan with an Account Number printed on it.
- v) While tendering the e-challan at the bank, the agency must ensure that the unique account number mentioned in the challan should be correctly mentioned as the account number in which funds to be remitted.
- vi) Upon executing the RTGS by the sender/remitter bank, the amount collected will be credited to relevant CAMPA state account with the Bank on real time basis.

II) Amount demanded for Tree extraction, logging and transportation in the forest area diverted to be deposited with Divisional Forest Officer (As per IGF, Ad-hoc, CAMPA Lr.No.12-2/2010-CAMPA, dated: 09-06-2016 communicated vide PCCF, S. Re.No.45921/2001/FCA-4 (I), dated: 04-07-2016)

If any payment is made by any other method, the same shall not be considered for compliance towards Stage I/II as per IGF Ad-hoc, CAMPA Lr.No.12-2/2010-CAMPA, dated: 14.07.2017.

It is also informed that, the user Agency shall submit the condition wise compliance as per the conditions stipulated in the reference cited. The conditions stipulated by the Government of Andhra Pradesh are reiterated here under.

- i) The legal status of the Forest land shall remain unchanged.
- ii) The demarcation of the forest area proposed for diversion shall be carried out by erecting cement concrete pillars duly numbered at an interval of 20 meters at the cost of the user Agency.
- iii) The user Agency shall pay the Net present Value (NPV) of the diverted Forest land as per the orders of the Hon'ble Supreme Court, dated: 28.03.2008 and 09.05.2008 in IA Nos.826 in 566 with related IA's in Writ Petition (Civil) No.202 of 1995 and as per the orders issued by Government of Andhra Pradesh vide G.O.Ms.No.124, EFS & T (For: I) Department, Dt.27.07.2010.
- iv) The funds from the user Agency towards Net Present value (NPV), under this project shall be deposited either in SB-A/c No.SB01025198, Compensatory Afforestation Fund (CAF), Andhra Pradesh, Corporation Bank, CGO Complex, Lodhi Road, New Delhi-110003 (RTGS/IFSC Code No.CORP0000371).
- v) Additional amount of the Net Present Value (NPV) of the diverted forest land, if any becoming due after revision of the same by the Hon'ble Supreme Court of India in future, shall be paid by the User Agency. The User Agency shall furnish an undertaking to this effect.
- vi) Other conditions specified in the handbook of guidelines issued by the Government of India, Ministry of Environment, Forests & Climate Change, letter dt 28.03.2019, shall also be complied with by Principal Chief Conservator of Forests (head of Forest Force) Andhra Pradesh and user Agency with which they are concerned.

vi) The total forest area utilized for the project shall not exceed 1.54 Ha. in case the land is not taken over by the User Agency or the same is not used for the stipulated purpose within a period of two years, then the area shall be taken back by the Forest Department.

vii) After receipt of compliance report of the above condition, the proposal will be considered for final approval. Transfer of forest land to the user agency shall not be effected prior to the issue of final approval. This approval shall be valid for a period of 5 years. In the event of non compliance of the above conditions, this approval shall automatically stand revoked.

In addition to the above, the User Agency is requested to comply with the following conditions in accordance with the Government of India instructions issued in F.No.7-23/2012-FC, dt.24.07.2013 communicated by the PCCF Re.No.45921/2001-F4, Dt.23.08.2013 and publish the orders at the cost of project proponent.

1. Publish the entire forest clearances granted in verbatim along with the conditions and safeguard imposed by the Central Government in two widely circulated daily news papers, one in vernacular language and another in English language so as to make people aware of the permission granted to the project proponent for use of forest land for non forestry purpose.
2. The copies of the forest clearance should also be submitted to the Heads of local bodies, Panchayats and Municipal Bodies by the project proponents in addition to the relevant offices of the Government who in turn have to display the same for 30 days.

Hence, the Executive Engineer, Panchayat Raj(PU) Division, Kakinada is requested to deposit the above said amounts and also submit the necessary certificates/documents on the above conditions stipulated by the Government of Andhra Pradesh and submit the compliance report to this office for onwards submission for final approval as per the Forest Conservation Act, 1980.
