In compliance of the Ministry of Environment and Forests (MoEF), Government of India's letter No.11-9/98-FC (pt.), dated:3rd August, 2009 wherein the MoEF issued guidelines on submission of evidences for having initiated and completed the process of settlement of rights under the Schedule Tribes and Other Traditional Forest Dwellers (Recognition of Forest Rights) Act, 2006 ('FRA; for short) on the forest land proposed to be diverted for non-forest purposes, it is certified that 112 hectare of forest land situated in Compt. Nos. 842 & 851, Khanapur Forest Block, Peddur Beat, Kaddam Range, Khanapur Forest Division proposed to be diverted in favour of the Field Director, Project Tiger & Conservator of Forests, Kawal Tiger Reserve, Nirmal, Telangana State Forest Department for Relocation & Rehabilitation of Maisampet & Rampur Villages of Kaddam Mandal in Nirmal District falls within the jurisdiction of Nachenyellapur Village in Kaddam Mandal, Nirmal District.

- a) The complete process for identification and settlement of Rights under the FRA has been carried out for the entire 112 hectares of forest area proposed for diversion. A copy of records of all consultations and meetings of the Forest Rights Committee, Gram Sabha, Sub-Division Level Committee and the District Level Committee are enclosed as Annexures-I to III.
- b) The proposals for such diversion/ denotification (with full details of the project and its implications, in vernacular/local language) have been placed before each concerned Gram Sabha of forest-dwellers, who eligible under the FRA;
- c) The Gram Sabha has certified that all formalities/processes under the FRA have been carried out, and that it has given its consent to the proposed diversion/denotification and the compensation and ameliorative measures, if any, having understood the purpose and details of proposed diversion/ denotification. A copy of certificate issued by the Gram Sabha of Nachenyellapur Village are enclosed as Annexure-I.
- d) The discussion and decisions on such proposals had taken place only when there was a quorum of minimum 50% of the members of Gram Sabha present;
- e) The diversion/ denotification of forest land for facilities managed by the Government as required under Section 3 (2) of the FRA have been completed and the Gram Sabha has given its consent to it;
- f) The rights of Primitive Tribal Groups and Pre-Agricultural Communities, where applicable have been specifically safeguarded as per Section 3 (1) (e) of the FRA.

Vide Rc. No.345/2016-K5, dt.09.06.2018, the Forest Divisional Officer, Khanapur has informed that the Telangana State Forest Department has decided to Relocate two (2) Villages namely Maisampet & Rampur of Kaddam Mandal, Nirmal District from the core area of the Kawal Tiger Reserve to the forest area in Compt. Nos.842 & 851, Khanapur Forest Block, Peddur Beat, Kaddam Range situated in the limits of Nachanyellapur GP, Kaddam Mandal to create inviolate space in the Tiger Reserve to ensure proper development of the best habitat for Tigers following the guidelines issued by the National Tiger Conservation Authority, MoEF, Government of India, New Delhi. Further informed that the District Level Implementation Committee meeting was held on 21.10.2017 under the Chairmanship of the District Collector and accordingly Relocation proposals were submitted to the Principal Chief Conservator of Forests (HoFF), Telangana, Hyderabad for further course of action. He further informed that as part of the Relocation, the proposed forest area over an extent of 112 ha. in Compt. Nos.842 & 851, Khanapur Forest Block needs to be denotified for rehabilitation of the said villagers for which a certificate in Form-II under RoFR Act, 2006 issued by the District Collector certifying that the process for identification and settlement of Rights under the RoFR Act has been carried out for the entire 112 ha. of forest area proposed for denotification is mandatory and finally requested to convene Sub-Divisional Level Committee meeting under RoFR Act and pass resolution to the effect that there is no objection for diversion/ denotification of the proposed forest land in favour of the Telangana Forest Department. Further, the Tahsildar, Kaddam has furnished a report vide his Rc. No.115/2018, dated:28.06.2018 informing that the complete process for identification and settlement of rights under the FRA has been carried out and Rights Certificates have been issued for 12 ST members in the Forest land over an extent of 12.3 acres and no application under FRA is pending at present and the entire land in question i.e., the land proposed for denotification/ diversion is in the possession of the Forest Department.

Accordingly, the Sub-Divisional Committee has convened a meeting on 16.07.2018 at 3.00 PM at RDOs office at Nirmal and after thorough verification of all the evidences and report of the Tahsildar, Kaddam unanimously passed a resolution to the effect that there is no objection for diversion/ denotification of the proposed forest land for Relocation of the Villages in favour of the Telangana Forest Department represented by the Field Director & Conservator of Forests, Kawal Tiger Reserve, Nirmal as there are no encroachments by the tribal people in the forest land to be diverted/denotified and further resolved that there are no claims pending under RoFR Act to be settled and to forward the request of the Forest Divisional Officer, Khanapur for consideration and issue of certificate in Form-II by the District Level Committee under RoFR Act.

At the outset the District Collector & Chairperson for District Level Committee under RoFR Act, 2006 welcomed all the members for the meeting. The Convener & RDO, Nirmal has appraised the details of the proposals submitted by the Forest Divisional Officer, Khanapur for diversion / denotification of forest land over an extent of 112 ha in Compt. Nos. 842 & 851, Khanapur Forest Block, Peddur Beat, Kaddam Range situated in the limits of Nachenyellapur of Kaddam Mandal u/s 2 of Forest (Conservation) Act, 1980 for Relocation of Maisampet & Rampur Villages of Kaddam Mandal from the Core area of Kawal Tiger Reserve for which a certificate in Form-II from the Chairperson, District Level Committee under RoFR Act, 2006 & District Collector, Nirmal is to be issued certifying that the process of settlement of rights under the RoFR Act, 2006 on the forest lands proposed to be diverted/denotified for the said purpose have been initiated and completed.

resolved that there are no claims pending to be settled under RoFR Act and unanimously resolved to forwarded the request of the Forest Divisional Officer, Khanapur for consideration and issue of certificate in Form-II by the District Level Committee under RoFR Act, 2006.

Therefore, the District Level Committee unanimously resolved to issue certificate in Form-II under RoFR Act, 2006 for diversion/denotification of the said forest lands in favour of the Telangana Forest Department represented by the Field Director/Conservator of Forests, Kawal Tiger Reserve, Nirmal.
