**DEMAND NOTICE**

Sub:- APFD – F.C. Act, 1980 – Proposal for diversion of 0.52 Ha of forest land for rehabilitation and upgradation of NH-221 (new NH-30) from Km 32.700 to km 72.200 (Chandragudem to AP/TS Border Section) in the state of AP to two lanes with paved shoulders on EPC Mode – in Krishnaraopalem RF (Compt.No.80) – in-principle (Stage-I) approval accorded – Demand Notice for payment of Net Present Value – Issued – Requested for conditions compliance - Reg.

In the reference 1<sup>st</sup> cited, the State Government has accorded in principle (Stage-I) approval for diversion of forest land u/s 2 of Forest Conservation Act, 1980 over an extent of 0.52 Ha of forest land for rehabilitation and upgradation of NH-221 (new NH-30) from Km 32.700 to km 72.200 (Chandragudem to AP/TS Border Section) in the state of AP to two lanes with paved shoulders on EPC Mode – in Krishnaraopalem RF (Compt.No.80) in favour of the Project Director, PIU, Ministry of Road Transport and Highways, Machilipatnam SC/SF.

The Prl. Chief Conservator of Forests (HoFF), A.P., Hyderabad had communicated the state government approval in principle (Stage-I) and instructed to raise Demand Notice to the User Agency for payment of Net Present Value (NPV) amount. The Prl.C.C.F. further instructed to obtain compliance as per the conditions stipulated in the reference 1<sup>st</sup> cited from the user agency.

For fulfillment of condition Nos.(iii) and (v) the user agency is requested to deposit the following amounts.

The user agency should pay the above said amount of Rs.3,95,520/- through e-payment mode i.e. challan generated through the ministry's website portal (i.e. [www.forestclearance.nic.in](http://www.forestclearance.nic.in)). The amount should be deposited either in SB A/c No.SB01025198, Compensatory Afforestation Fund (CAF), Andhra Pradesh, Corporation Bank, CGO Complex, Lodhi Road, New Delhi-110 003 (RTGS/IFSC No.CORP0000371) or in SB A/c No.344902010105407 – Andhra Pradesh CAMPA, Union Bank of India, Sundar Nagar, New Delhi-110003 (RTGS/IFSC No.UBINO534498).

The User agency is also requested to submit conditions wise compliance as stipulated in 1<sup>st</sup> reference cited. In addition to the above the user agency should comply the following in accordance with the Government of India instructions issued vide F.No.7-23/2012-FC, dt. 24-07-2013.

1. Publish the entire forest clearances granted in verbatim along with the conditions and safe-guards imposed by the Central Government in two widely circulated daily newspapers, one in vernacular language and the other in English language, so as to make people aware of the permission granted to the project proponent for use of forest land for non-forest purposes.

2. The copies of the Forest clearance should also be submitted to the Heads of local bodies, Panchayats and Municipal Bodies by the project proponents in addition to the relevant offices of the Government who in turn has to display the same in 30 days.

Further, the user agency is requested to submit unconditional undertaking on Rs.100/- judicial stamped paper to pay the revised amount of Net Present Value of the diverted forest area if any becoming due after revision of the same by the Supreme Court of India in future. The User Agency should note that transfer of forest land should be effected only after according of final approval.

The receipt of the demand notice may please be acknowledged on the duplicate copy and resubmit the same to this office by return of post.
