

**Joint verification Report of Non-forest Govt. Land identified for Compensatory
Afforestation in Parmanpur village under Kolabira Tahasil of Jharsuguda District for
Aheerajore irrigation Project.**

In pursuance to letter no-5676 dt-27/06/15, of the O/O The Collector, Jharsuguda, a joint verification was taken up with the staff of revenue and forest department for identification of 36 ac (14.54 ha) Non-forest Government land in Parmanpur village under Kolabira Tahasil.

During the course of joint verification, the land so identified was found to be free from encroachment and encumbrance. There isn't any minor mineral deposit in the land. Out of the 64.63 ac land verified 36 ac (14.54ha) land found suitable for raising compensatory afforestation. The lands are available in single compact patch. There isn't any valuable tree growth in the land.

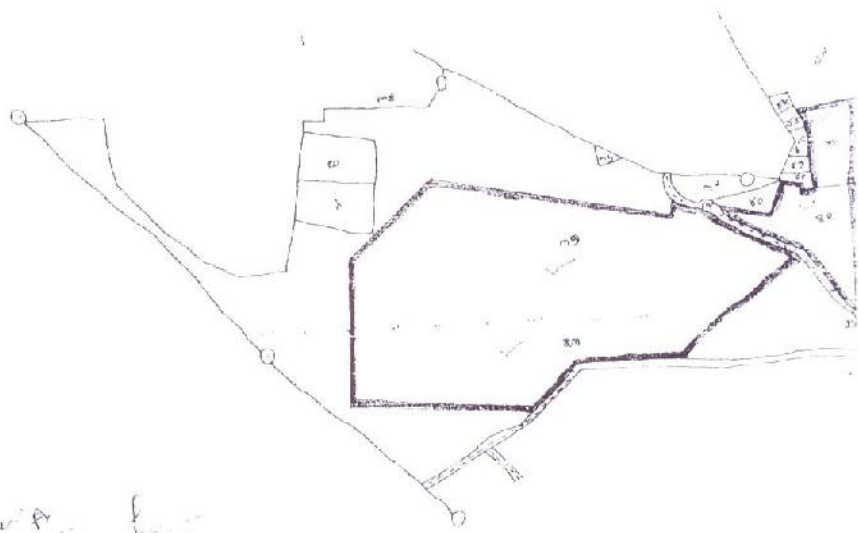
